18 The Commissioner ("Commissioner") of the California Department of Real Estate  
19 ("Department") caused an investigation to be made of the activities of SANTA BARBARA  
20 MANAGEMENT, GLOBAL AMERICA, GLOBAL TEAM CONSULTING, USA HOME  
21 RECOVERY SERVICE, MIKE AGUILAR, FELIPE CARLOS SEGOVIA, DHELMY  
22 FLORES, VICKY SANTOS and FRANCISCO SANTANA. Based on that investigation the  
23 Commissioner has determined that SANTA BARBARA MANAGEMENT, GLOBAL  
24 AMERICA, GLOBAL TEAM CONSULTING, USA HOME RECOVERY SERVICE, MIKE  
25 AGUILAR, FELIPE CARLOS SEGOVIA, DHELMY FLORES, VICKY SANTOS and  
26 FRANCISCO SANTANA have engaged in, or are engaging in, acts, or are attempting to engage  
27 in the business of, acting in the capacity of, and/or advertising or assuming to act as real estate

1 brokers in the State of California within the meaning of Business and Professions Code Sections  
2 10131(d) (soliciting or negotiating loans or collecting payments or performing services for  
3 borrowers in connection with loans secured by real property) and 10131.2 (advance fee  
4 handling).

5 In addition, based on that investigation, the Commissioner has determined that  
6 SANTA BARBARA MANAGEMENT, GLOBAL AMERICA, GLOBAL TEAM  
7 CONSULTING, USA HOME RECOVERY SERVICE, MIKE AGUILAR, FELIPE CARLOS

12 below, the Commissioner hereby issues the following Findings of Fact, Conclusions of Law, and  
13 Desist and Refrain Order under the authority of Section 10086 of the Code.

14 FINDINGS OF FACT

17 CONCLUSIONS OF LAW

18 3. Based on the information contained in Paragraphs 1 and 2 above, SANTA  
19 BARBARA MANAGEMENT, GLOBAL AMERICA, GLOBAL TEAM CONSULTING, USA  
20 HOME RECOVERY SERVICE, MIKE AGUILAR, FELIPE CARLOS SEGOVIA, DHELMY  
21 FLORES, VICKY SANTOS and FRANCISCO SANTANA violated Code Section 10130 by  
22 engaging in activities requiring broker licenses without first obtaining broker licenses from the  
23 Department.

24 DESIST AND REFRAIN ORDER


25 Based upon the FINDINGS OF FACT and CONCLUSIONS OF LAW stated  
26 herein, it is hereby ordered that SANTA BARBARA MANAGEMENT, GLOBAL AMERICA,  
27 GLOBAL TEAM CONSULTING, USA HOME RECOVERY SERVICE, MIKE AGUILAR,

1 FELIPE CARLOS SEGOVIA, DHELMY FLORES, VICKY SANTOS and FRANCISCO  
2 SANTANA, whether doing business under their own names, or any other names, or any  
3 fictitious names, are hereby ordered to immediately desist and refrain from performing any acts  
4 within the State of California for which a real estate broker license is required. In particular,  
5 they are ORDERED TO DESIST AND REFRAIN from:

- 6 1. charging, demanding, claiming, collecting and/or receiving advance fees, as  
7 that term is defined in Section 10026 of the Code, in any form, and under any  
8 conditions, with respect to the performance of loan modification or any other  
9 form of mortgage loan forbearance services in connection with loans on  
10 residential property containing four or fewer dwelling units; and
- 11 2. charging, demanding, claiming, collecting and/or receiving advance fees, as  
12 that term is defined in Section 10026 of the Code, for any of the other real  
13 estate related services offered to others.

21 **Notice:** Business and Professions Code Section 10139 provides that "Any person acting as a  
22 real estate broker or real estate salesperson without a license or who advertises using words  
23 indicating that he or she is a real estate broker without being so licensed shall be guilty of a  
24 public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by  
imprisonment in the county jail for a term not to exceed six months, or by both fine and  
imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars  
(\$60,000)."

18 3. Based on the information contained in Paragraphs 1 and 2 above, SANTA  
19 BARBARA MANAGEMENT, GLOBAL AMERICA, GLOBAL TEAM CONSULTING, USA  
20 HOME RECOVERY SERVICE, MIKE AGUILAR, FELIPE CARLOS SEGOVIA, DHELMY  
21 FLORES, VICKY SANTOS and FRANCISCO SANTANA violated Code Section 10130 by  
22 engaging in activities requiring broker licenses without first obtaining broker licenses from the  
23 Department.

24 DESIST AND REFRAIN ORDER


25 Based upon the FINDINGS OF FACT and CONCLUSIONS OF LAW stated  
26 herein, it is hereby ordered that SANTA BARBARA MANAGEMENT, GLOBAL AMERICA,  
27 GLOBAL TEAM CONSULTING, USA HOME RECOVERY SERVICE, MIKE AGUILAR,

1 FELIPE CARLOS SEGOVIA, DHELMY FLORES, VICKY SANTOS and FRANCISCO  
2 SANTANA, whether doing business under their own names, or any other names, or any  
3 fictitious names, are hereby ordered to immediately desist and refrain from performing any acts  
4 within the State of California for which a real estate broker license is required. In particular,  
5 they are ORDERED TO DESIST AND REFRAIN from:

- 6 1. charging, demanding, claiming, collecting and/or receiving advance fees, as  
7 that term is defined in Section 10026 of the Code, in any form, and under any  
8 conditions, with respect to the performance of loan modification or any other  
9 form of mortgage loan forbearance services in connection with loans on  
10 residential property containing four or fewer dwelling units; and
- 11 2. charging, demanding, claiming, collecting and/or receiving advance fees, as  
12 that term is defined in Section 10026 of the Code, for any of the other real  
13 estate related services offered to others.

21 **Notice:** Business and Professions Code Section 10139 provides that "Any person acting as a  
22 real estate broker or real estate salesperson without a license or who advertises using words  
23 indicating that he or she is a real estate broker without being so licensed shall be guilty of a  
24 public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by  
imprisonment in the county jail for a term not to exceed six months, or by both fine and  
imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars  
(\$60,000)."
