The Commissioner (Commissioner) of the California Department of Real Estate (Department) caused an investigation to be made of the activities of TRANSFER SMART LLC ("TS"). Based on the investigation, the Commissioner has determined that TS has engaged in, is engaging in, or is attempting to engage in, acts or practices constituting violations of the California Business and Professions Code ("Code"), including the business of, acting in the capacity of, and/or advertising or assuming to act as, a real estate broker in the State of California within the meaning of Code Sections 10131(a) (soliciting and obtaining listings, and negotiating the purchase, sale or exchange of real property) and

1 10131.2 (charging an advance fee in connection with the purchase,  
2 sale, exchange or listing of real property). Furthermore, based  
3 on the investigation, the Commissioner hereby issues the  
4 following Findings of Fact, Conclusions of Law, and Desist and  
5 Refrain Order under the authority of Section 10086 of the Code.

6 Whenever acts referred to below are attributed to TS,  
7 those acts are alleged to have been done by TS, acting by itself,  
8 or by and/or through one or more agents, associates, affiliates,  
9 and/or co-conspirators.

10 FINDINGS OF FACT

11 1. At no time herein mentioned has TS been licensed by the  
12 Department in any capacity.

13 2. During the period of time set out below, TS solicited  
14 real property listings and collected an advance fee to do one  
15 or more of the following acts for another or others, for or in  
16 expectation of compensation: offer to list for sale, and  
17 negotiate the purchase, sale or exchange of interests in real  
18 property, to wit: timeshares.

19 3. For an unknown period of time prior to November, 2010,  
20 through and including the present time, TS advertised, and  
21 continue to advertise, its services under the business name  
22 TRANSFER SMART on a website located at  
23 <http://www.transfersmartnow.com>. Those advertisements  
24 solicited, and continue to solicit for sale listings and offer  
25 to arrange purchases, sales or exchanges of timeshare  
26 properties in exchange for the payment of an advance fee.

1 4. On or about November 21, 2010, TS entered into a written  
2 agreement with Eleanor K. concerning the sale or exchange of  
3 her timeshare property, obligating Eleanor K. to pay to TS as  
4 its advance fee for services \$4,736.00 in violation of Code  
5 Sections 10130, 10131(a) and 10131.2.

6 CONCLUSIONS OF LAW


7 5. Based on the findings of fact contained in paragraphs 1  
8 through 4, TS, acting by itself, or by and/or through one or  
9 more agents, associates, affiliates, and/or co-conspirators  
10 solicited real property listings and collected an advance fee  
11 to do one or more of the following acts for another or others,  
12 for or in expectation of compensation: offer to list for sale,  
13 and/or negotiate the purchase, sale or exchange of interests in  
14 real property, to wit: timeshares, which requires a real estate  
15 license under Code Sections 10131(a) and 10131.2, during a  
16 period of time when neither TG and WEST were licensed by the  
17 Department in any capacity, in violation of Code Section 10130.

19  
20 DESIST AND REFRAIN ORDER

21 Based on the Findings of Fact and Conclusions of Law  
22 stated herein, TRANSFER SMART LLC IS HEREBY ORDERED to  
23 immediately desist and refrain from performing any acts within  
24 the State of California for which a real estate broker license is  
25 required, and in particular, doing one or more of the following  
26 acts for another or others, for or in expectation of  
27 compensation: offer to list for sale, and/or negotiate the

1 purchase, sale or exchange of interests in real property, unless  
2 and until TRANSFER SMART LLC obtains a real estate broker license  
3 issued by the Department.

13 **Notice:** Business and Professions Code Section 10139 provides  
14 that "Any person acting as a real estate broker or real estate  
15 salesperson without a license or who advertises using words  
16 indicating that he or she is a real estate broker without being  
17 so licensed shall be guilty of a public offense punishable by a  
18 fine not exceeding twenty thousand dollars (\$20,000), or by  
19 imprisonment in the county jail for a term not to exceed six  
20 months, or by both fine and imprisonment; or if a corporation, be  
21 punished by a fine not exceeding sixty thousand dollars  
22 (\$60,000)."
