On or about June 24, 2011, in the Superior Court of the State of California, County of Santa Clara, Case No. LA 065902, Respondent was convicted of violating Sections 2945.4(g)/2945.7 of the California Civil Code (Induce Another to Enter Unlawful Contract), a felony and Section 6126(a) of the California Business and Professions Code (Unauthorized Practice of Law), a misdemeanor, both crimes which bear a substantial relationship under Section 2910, Title 10, California Code of Regulations, to the qualifications, functions, or duties of a real estate licensee.

Cause for disciplinary action against Respondent exists with reference to the conviction set out in Paragraph 3, above, pursuant to Business and Professions Code Sections 490 and 10177(b).

The standard of proof applied was clear and convincing proof to a reasonable certainty.


ORDER





15 State of California, for cause of Accusation against MARY MARGARET DEL VECCHIO,
16 (hereinafter Respondent), is informed and alleges as follows:

18 Complainant makes this Accusation against Respondent in his official capacity.

20 Respondent is presently licensed and/or has license rights under the Real Estate

24 On or about June 24, 2011, in the Superior Court of the State of California,
25 County of Santa Clara, Case No. LA 065902, Respondent was convicted of violating Sections
26 2945.4(g)/2945.7 of the California Civil Code (Induce Another to Enter Unlawful Contract), a
27 felony and Section 6126(a) of the California Business and Professions Code (Unauthorized

5 The facts alleged in Paragraph 3, above, constitute cause under Section 10177(b)

8 under the Real Estate Law.

9 WHEREFORE, Complainant prays that a hearing be conducted on the allegations
10 of this Accusation and that upon proof thereof, a Decision be rendered imposing disciplinary
11 action against all licenses and license rights of Respondent under the Code, and for such other
12 and further relief as may be proper under provisions of law.
