2	Effective September 19, 2005, in Case No. H-1772 FR, before the Department,
3	the Real Estate Commissioner denied Respondent JARA's application for a real estate broker
4	license pursuant to Sections 480(a) and 10177(b) of the Code.
5	12.
6	The facts alleged in Paragraphs 3 through 9 above indicate Respondents' failure
7	to comply with Sections 10186.2(a)(1)(A) and 10186.2(a)(2) (failure to report in writing to the
8	Department the bringing of an indictment or information charging a felony against Respondent
9	within 30 days) of the Code, and constitute cause under Section 10177(d) (willful disregard or
10	violation of the Real Estate Law; Part 1 of Division 4 of the Business and Professions Code) for
11	revocation of all licenses and license rights of Respondents under said Real Estate Law.
12	13.
13	Section 10106 of the Code provides, in pertinent part, that in any order issued in
14	resolution of a disciplinary proceeding before the Department, the Commissioner may request
15	the Administrative Law Judge to direct a licensee found to have committed a violation of this
16	part to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the
17	case.
18	WHEREFORE, Complainant prays that a hearing be conducted on the
19	allegations of this Accusation and that upon proof thereof, a decision be rendered imposing
20	disciplinary action against all licenses and license rights of Respondents under the Real Estate
21	Law (Part 1 of Division 4 of the Business and Professions Code), and for such other and further
22	relief as may be proper under other provisions of law.
