The Real Estate Commissioner of the State of California (hereinafter "the Commissioner") has caused an investigation to be made of your activities selling or offering to sell lots or units in a subdivision as defined in Sections 11000 and 11004.5 of the California Business and Professions Code (hereinafter "the Code"), and based upon the findings of that investigation, as set forth below, has determined that you, SOLANO PACIFIC CORPORATION, a Corporation, RICHARD ALAN

materially from the exemplar sales agreement described in Paragraph XI, above:
