On MAYZZ, 2012, Donald John-Mark Kenney petitioned the Commissioner to voluntarily surrender the real estate broker license issued in his name pursuant to Section 10100.2 of the Business and Professions Code.

IT IS HEREBY ORDERED that DONALD JOHN-MARK KENNEY's petition for voluntary surrender of the real estate broker license issued in his name is accepted as of the effective date of this Order as set forth below, based upon the understanding and agreement expressed in Respondent's Declaration dated \underline{MAYZZ} , 2012. (attached as Exhibit "A" hereto).

IT IS ALSO ORDERED that, in the event that DONALD JOHN-MARK

KENNEY applies for a California real estate license in the future, his surrender of real estate broker license number 01246846 issued to Donald John Kenney will not, in any way, hinder or compromise his ability to obtain a valid real estate license in his name.

The Department of Real Estate acknowledges and confirms that, as of the date of this ORDER, it has received no information that Donald John-Mark Kenney has engaged in the unauthorized practice of real estate in the State of California
