2	On or about March 26, 2015, Respondent pled guilty and was convicted in the
3	Superior Court of California, County of San Diego, Case No. SCD255289, for violation of
4	California Unemployment Insurance Code Section 2117.5 (Acting With Intent To Evade Tax),
5	a misdemeanor, and Labor Code Section 3700.5(a) (Failure To Secure The Payment Of
6	Compensation), a misdemeanor. Respondent was placed on three years of summary probation,
7	and ordered to pay restitution, fines and fees. Additionally, Respondent was ordered to
8	complete 14 days of the Public Service Program.
9	4.
10	The convictions described in Paragraph 3 bear a substantial relationship under
11	Section 2910, Title 10, Chapter 6, California Code of Regulations to the qualifications,
12	functions or duties of a real estate licensee.
. 13	5.
14	The crimes of which Respondent was convicted, as described in Paragraph 3
15	above, constitute cause under Sections 490 and 10177(b) of the Code for the suspension or
16	revocation of the license and license rights of Respondent under the Real Estate Law.

18	Code Section 10106 provides, in pertinent part, that in any order issued in
19	resolution of a disciplinary proceeding before the Bureau of Real Estate, the Commissioner may
20	request the administrative law judge to direct a licensee found to have committed a violation of
21	this part to pay a sum not to exceed the reasonable costs of the investigation and enforcement of
22	the case.
