STIPULATION AND WAIVER

I, Mark Leslie Goldstein ("Respondent") do hereby affirm that I have applied to the Bureau of Real Estate ("Bureau") for a real estate salesperson license, and that to the best of my knowledge I have satisfied all of the statutory requirements for the issuance of the license, including, but not limited to, the payment of the fee therefor.

I acknowledge that by entering into this Stipulation and Waiver, I am stipulating that the Real Estate Commissioner ("Commissioner") has found grounds that justify the denial of the issuance of an unrestricted real estate salesperson license to me. I agree that there are grounds to deny the issuance of an unrestricted real estate salesperson license to me pursuant to Section 10177(a) of the Business and Professions Code ("Code") for failing to disclose a then pending criminal charge in the United States District Court, Southern District of California, Case No. 11CR3486-JAH, on my real estate salesperson application.

I hereby request that the Commissioner in his discretion issue a restricted real estate salesperson license to me under the authority of Sections 10100.4 and 10156.5 of the Code. I

RE 511 L (Rev. 8-16) RE 511 L (Rev. 8-16) understand that any such restricted license will be issued subject to the provisions and limitations of Sections 10156.6 and 10156.7 of the Code.

I understand that by my signing of this Stipulation and Waiver, provided this Stipulation and Waiver is accepted and signed by the Commissioner, the Commissioner will not file a Statement of Issues based on the grounds herein, and I am waiving my right to a hearing and the opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain an unrestricted real estate salesperson license.

I agree that by signing this Stipulation and Waiver, the conditions, limitations, and restrictions imposed on my restricted license, identified below, may be removed only by filing a Petition for Removal of Restrictions ("Petition") with the Commissioner, and that my Petition must follow the procedures set forth in Government Code Section 11522.

I further understand that the restricted license issued to me shall be subject to all of the provisions of Section 10156.7 of the Code and to the following limitations, conditions and restrictions imposed under authority of Section 10156.6 of the Code:

- 1. The restricted license shall not confer any property right in the privileges to be exercised including the right of renewal, and the Commissioner may by appropriate order suspend the right to exercise any privileges granted under the restricted license in the event of:
  - a. Respondent's conviction (including a plea of nolo contendere) of a crime that
    bears a substantial relationship to Respondent's fitness or capacity as a real estate
    licensee; or
  - b. The receipt of evidence that Respondent has violated provisions of the California Real Estate Law, the Subdivided Lands Law, Regulations of the Commissioner, or conditions attaching to the restricted license.
- 2. Respondent shall not be eligible to petition for the issuance of an unrestricted real estate license nor the removal of any of the conditions, limitations, or restrictions attaching to the restricted license until two (2) years have elapsed from the date of issuance of the restricted license to Respondent. Respondent shall not be eligible to

apply for any unrestricted licenses until all restrictions attaching to the license have been removed.

- Respondent shall notify the Commissioner in writing within seventy-two (72) hours of any arrest by sending a certified letter to the Commissioner at the Bureau of Real Estate, Post Office Box 137013, Sacramento, CA 95813-7013. The letter shall set forth the date of Respondent's arrest, the crime for which Respondent was arrested, and the name and address of the arresting law enforcement agency. Respondent's failure to timely file written notice shall constitute an independent violation of the terms of the restricted license and shall be grounds for the suspension or revocation of that license.
- With the application for license or with the application for transfer to a new employing broker, Respondent shall submit a statement signed by the prospective employing broker on a form approved by the Bureau wherein the employing broker shall certify as follows:
  - That the broker has read the Stipulation and Waiver which is the basis for the issuance of the restricted license; and
  - That the broker will carefully review all transaction documents prepared by the b. restricted licensee and otherwise exercise close supervision over the licensee's performance of acts for which a license is required.
