

DECLARATION  
VOLUNTARY SURRENDER OF LICENSE  
(Business and Professions Code Section 10100.2)

My name is JOHN RICHARD VANZETTI. I am currently licensed as a real estate broker and/or have license rights with respect to said license. I am represented by Christopher Wing in this matter.

I have been informed by Kyle Jones, identified to me as a Deputy Real Estate Commissioner, that an investigation by the California Department of Real Estate (hereinafter "Department") is now pending against me.

I hereby petition to voluntarily surrender the real estate license(s) issued by the Department to me, pursuant to Business and Professions Code Section 10100.2.

It is understood that by so voluntarily surrendering these license(s), I may be relicensed as a broker or as a salesperson only by petitioning for reinstatement pursuant to



1 Section 11522 of the Government Code. I also understand that by so voluntarily surrendering  
2 said license(s), I agree to the following:

3           The filing of this Declaration shall be deemed as my petition for voluntary  
4 surrender. It shall also be deemed to be an understanding and agreement that upon acceptance by  
5 the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence  
6 obtained in the investigation prior to the acceptance may be considered by the Department to be  
7 true and correct for the purpose of deciding whether to grant relicensure or reinstatement  
8 pursuant to Government Code Section 11522.

9           I declare under penalty of perjury under the laws of the State of California that the  
10 above is true and correct and I freely and voluntarily surrender all our license(s) and license  
11 rights under the Real Estate Law.
