15	The Commissioner ("the Commissioner") of the California Department of Real
16	Estate ("the Department") caused an investigation to be made of the activities of PEACE
17	AND FREEDOM LEGAL SERVICES, ("PFLS"), KARLA BARBOSA, ("BARBOSA"), and
18	ANGELINA MIRELES, ("MIRELES"), (collectively "Respondents"). Based on that
19	investigation, the Commissioner has determined that Respondents have engaged in, are
20	engaging in, or are attempting to engage in, acts or practices constituting violations of the
21	California Business and Professions Code ("Code") and/or Title 10, Chapter 6, California
22	Code of Regulations ("Regulations"), including acting in the capacity of, advertising or
23	assuming to act as a real estate broker in the State of California within the meaning of Section
24	10131(d) (soliciting services for borrowers and/or lenders in connection with loans secured by
25	real property). Furthermore, based on the investigation, the Commissioner hereby issues the
26	following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the
27	authority of Section 10086 of the Code.

1	FINDINGS OF FACT
2	1. At all times relevant, PFLS was not licensed by the Department to conduct real
3	estate activity in the State of California.
4	2. At all times relevant, BARBOSA was not licensed by the Department to
5	conduct real estate activity in the State of California.
6	3. At all time relevant, MIRELES was licensed as a real estate salesperson by the
7	Department in the employ of Legacy Home Loans & Real Estate.
8	4. During the period of time set out below, Respondents solicited borrowers
9	and/or performed services for one or more borrowers and negotiated to do one or more of the
10	following acts for another or others, for or in expectation of compensation: negotiate one or
11	more loans for, or perform services for, borrowers and/or lenders with respect to the collection
12	of advance fees and loan modification, loan refinance, principal reduction, foreclosure
13	abatement or short sale services and/or those borrowers' lenders in connection with loans
14	secured directly or collaterally by one or more liens on real property.
15	5. In or about January 2011, in furtherance of their plan and scheme to solicit
16	advance fees and provide loan modification services, Respondents advertised by flyer to
17	provide loan modification services to the general public.
18	CONCLUSIONS OF LAW
19	6. Based on the Findings of Fact contained in Paragraphs 1 through 5, above,
20	PEACE AND FREEDOM LEGAL SERVICES, KARLA BARBOSA and ANGELINA
21	MIRELES solicited borrowers and/or performed services for those borrowers with respect to
22	the collection of advance fees and loan modification, loan refinance, principal reduction,
23	foreclosure abatement or short sale services and/or those borrowers' lenders in connection
24	with loans secured directly or collaterally by one or more liens on real property, which acts
25	require a real estate broker license under Sections 10130 (broker license requirement) and
26	10131(d) (broker definition) of the Code.
