The Real Estate Commissioner of the State of California has caused an investigation to be conducted and is of the opinion that FIRST HOME, INC. (herein "FHI"), a California corporation, (CREB # 01202609) and WALTER ZHOVREBOFF, (REB #661978) (herein "ZHOVREBOFF"), as the designated corporate officer of FHI, have engaged in activities requiring a corporate real estate broker license under Section 10131(a) of the California Business and Professions Code (hereafter "the Code"), while the corporate status of FHI has been suspended, in violation of Section 2742(c) of Chapter 6, Title 10, California Code of Regulations (hereinafter "the Regulations") in conjunction with Section 10177(d) of the Code.

## FINDINGS OF FACT

- 1. On or about July 1, 2008 and continuing through the present, the corporate powers, rights and privileges of FHI were suspended by the California Franchise Tax Board pursuant to the provisions of the California Revenue and Taxation Code, and FHI's legal standing with the California Office of the Secretary of State was "suspended." As a result of the suspension of its corporate privileges, at no time herein mentioned was FHI entitled to conduct business in the State of California as a corporate real estate broker.
- 2. Between approximately July 1, 2008 and the present, FHI engaged in the business of, acted in the capacity of, advertised, or assumed to act as a real estate broker within the State of California within the meaning of Section 10131(a) of the Code, including the operation and conduct of a real estate resale brokerage business with the public wherein, on behalf of others, for compensation or in expectation of compensation, FHI solicited borrowers or lenders for or negotiated loans or collected payments or performed services for borrowers or lenders or note owners in connection with loans secured directly or collaterally by liens on real property or on a business opportunity pursuant to Section 10131(a), including, but not limited to, the following real estate loan transactions:

### CONCLUSIONS OF LAW

3. In acting as described in paragraphs 1 and 2 above, FHI and ZHOVREBOFF have violated Section 2742(c) of the Regulations (Corporation shall not engage in the business of real estate broker while not in good legal standing with the Office of the Secretary of State) in conjunction with Section 10177(d) of the Code (Willful disregard or violation of real estate law).

### NOTICE
