STATEMENT REGARDING VOLUNTARY SURRENDER OF LICENSE

I am aware that the Department of Real Estate is conducting an investigation (DRE File #509 0323 010) related to current and pending Federal Court cases, #CR-07-0654 and #CR10-00422 and Appellate Court case #09-10128, in which I am named as a defendant.
