 Department in this matter prior to the Commissioner's acceptance, and all allegations contained
 in the Accusation filed in the Department Case No. H-12319 SF may be considered by the
 Department to be true and correct for the purpose of deciding whether to grant re-licensure or
 reinstatement pursuant to Government Code section 11522.

4. PESSAH further understands and agrees that upon acceptance by the
Commissioner, as evidenced by an appropriate order, of His petition to voluntarily surrender all
