## DECISION

Respondent is in violation of Business and Professions Code Section 10148.

# DETERMINATION OF ISSUES

I

Cause for disciplinary action against Respondent exists pursuant to Business and Professions Code Section  $10177\,(d)$ .

The standard of proof applied was clear and convincing proof to a reasonable certainty.

#### ORDER

The licenses and license rights of Respondent PLATINUM SENSOR COMPANY, INC., under the provisions of Part 1 of Division 4 of the Business and Professions Code are revoked.
