2	would not be against the public interest to issue said license to Respondent.
3	NOW, THEREFORE, IT IS ORDERED that Respondent's petition for
4	reinstatement is granted and that a real estate salesperson license be issued to Respondent if
5	Respondent satisfies the following conditions within twelve (12) months from the date of this
6	order:
7	1. Submits a completed application and pays the fee for a real estate
8	salesperson license within the 12 month period following the date of this Order; and
9	2. Submits proof that Respondent has completed the continuing education
10	requirements for renewal of the license sought. The continuing education courses must be
11	completed either (i) within the 12 month period preceding the filing of the completed
12	application, or (ii) within the 12 month period following the date of this Order.
13

15	This Order shall become effective immediately.
