The Real Estate Commissioner of the State of California (Commissioner) has caused an investigation to be conducted of your activities, as described herein, and based upon the findings of that investigation, is of the opinion that you, ALBERTO I.

JIMENEZ dba World Market Realty, have violated Sections

17006(a)(4) and 17403.4 of the California Financial Code (Code).

At all times mentioned, you, ALBERTO I. JIMENEZ

("JIMENEZ"), were licensed or had license rights issued by the

Department of Real Estate ("Department") as a real estate broker.

On May 2, 1998, you were originally licensed as a real estate

salesperson. On June 24, 2002, you were originally licensed as a real estate broker.

At all times mentioned, in the City of Mission Hills, County of Orange, you, JIMENEZ, acted as real estate broker and conducted licensed activities within the meaning of:

- A. Code Section 10131(a). You operated a residential resale brokerage dba World Market Realty; and
- B. Conducted broker-controlled escrows through his escrow division, under the exemption set forth in California Financial Code Section 17006(a)(4) for real estate brokers performing escrows incidental to a real estate transaction where the broker is a party and where the broker is performing acts for which a real estate license is required.

On March 9, 2007, the Department completed an audit examination of the books and records of you, JIMENEZ, pertaining to the broker-controlled escrow activities described in Paragraph 2, that require a real estate license. The audit examination covered a period of time beginning on October 1, 2003 through September 30, 2006. The audit examination revealed violations of the Code and the Regulations as set forth below, and more fully discussed in Audit Report LA 060059 and the exhibits and workpapers attached to said audit report.
