

ORDER TO DESIST AND REFRAIN

The Real Estate Commissioner of the State of California has caused an investigation to be made of your activities as a real estate broker, and based on the findings of that investigation is of the opinion that JEFFREY THOMAS KONOPKA, individually, and doing business as TMMG Inc, has violated Sections 10159.5, 10235, 10235.5, 10236.4 and 17539.4 of the Business and Professions Code (hereinafter "Code") as well as Sections 2731, 2847.3, and 2848 subdivisions (16), (17) and (18) of Chapter 6, Title 10, California Code of Regulations (hereinafter "Regulations").

At all times mentioned herein, you, JEFFREY THOMAS KONOPKA, individually, and doing business as TMMG Inc, were

licensed by the Department of Real Estate of the State of California (hereinafter "Department") as a real estate broker.

You, JEFFREY THOMAS KONOPKA, individually, and doing business as TMMG Inc, knowingly advertised, printed, displayed, published, distributed, or caused or permitted to be advertised, printed, displayed, published, distributed, statements or representations with regard to the rates, terms, or conditions for making, purchasing, or negotiating loans on real property which were false, misleading, or deceptive.

Your conduct, as alleged in Paragraph 2, above, is in violation of Code Section 10235 and Section 2848 subdivisions (16), (17) and (18) of the Regulations.

You, JEFFREY THOMAS KONOPKA, individually, and doing business as TMMG Inc, placed one or more advertisements disseminated primarily in the State of California for the making or arranging of a loan, including a solicitation for borrowers or potential investors, that failed to disclose within the printed text of the advertisement, or the oral text in the case of a radio or television advertisement, your broker license number and proper identification of the Department as the state regulatory entity supervising that type of loan transaction.

Your conduct, as alleged in Paragraph 4, above, is in violation of Code Sections 10235.5, 10236.4 and 17539.4 and

Section 2847.3 of the Regulations.

You, JEFFREY THOMAS KONOPKA, individually, and doing business as TMMG Inc, placed one or more advertisements disseminated primarily in the State of California for the making or arranging of a loan, including a solicitation for borrowers or potential investors, that used a fictitious name without holding a license bearing that fictitious name.

Your conduct, as alleged in Paragraph 6, above, is in violation of Code Section 10159.5 and Section 2731 of the Regulations.
