ORDER SUSPENDING REAL ESTATE LICENSE

On December 16, 2009, CRAIG ROLAND DAHL ("Respondent") entered into a Stipulation and Agreement with the Department of Real Estate (now the Bureau of Real Estate "Bureau"). The terms of the Agreement required Respondent to pay for the audit as set forth in the Real Estate Commissioner's Decision in Case No. H-36098 LA, effective June 8, 2011. The Commissioner has determined that Respondent have failed to satisfy this condition by not paying for the total cost of the audit in the amount of \$4,113.62.

1 NOW, THEREFORE, IT IS ORDERED that the restricted real
2 estate salesperson license heretofore issued to Respondent and
3 the exercise of any privileges thereunder are hereby suspended
4 until such time as Respondent provides proof satisfactory to the
5 Bureau of having paid for the audit referred to above or pending
6 final determination made after hearing (see "Hearing Rights" set
7 forth below) or until Respondent enter into an agreement
8 satisfactory to the Commissioner to provide or payment.

9 IT IS FURTHER ORDERED that all license certificates
10 and identification cards issued by the Bureau of Real Estate
11 which are in the possession of Respondent be immediately
12 surrendered by personal delivery or by mailing in the enclosed
13 self-addressed envelope to:


17 HEARING RIGHTS: you have the right to a hearing to
18 contest the Commissioner's determination that you are in
19 violation of the condition that you pay for the audit. If you
20 desire a hearing, you must submit a written request. The
21 request may be in any form as long as it is in writing and
22 indicates that you want a hearing. Unless a written request for
23 a hearing, signed by or on behalf of you, is delivered or mailed
24 to the Bureau at 320 West Fourth Street, Suite 350, Los Angeles,
25 California 90013, within 20 days after the date that this Order
26 was mailed to or served on you, the Bureau will not be obligated
27 or required to provide you with a hearing.
