ORDER TO DESIST AND REFRAIN

(B&P Code Section 10086)

The Commissioner ("Commissioner") of the California Department of Real Estate ("Department") caused an investigation to be made of the activities of UNITED FIRST INC., PAUL H. NOE II, LINA NORENO, JENNY SANDOVAL, JEFFREY HERNANDEZ, NELLY ALVAREZ, JOSE ARMANDO PEREZ, ANNA RODRIGUEZ, ALFRED HUNDLEY, JONATHAN NOE, UFS EAGLES INC., HUGO GONZALEZ, TAMARA GONZALEZ,

AUDIT YOUR LOAN, also known as AUDIT YOUR LOAN USA, and WILLIAM R. BARAHONA, individually, and as Audit Your Loan, and has determined that they have each engaged in or are engaging in acts or practices constituting violations of the California Business and Professions Code ("Code") and/or Title 10, California Code of Regulations ("Regulations") including engaging in the business of, acting in the capacity of, engaging in the business of, acting in the capacity of, advertising, or assuming to act, as real estate broker in the State of California within the meaning of Section 10131(d) (soliciting borrowers or lenders or 10 negotiating loans) and Section 10131.2 (advance fee handling). Based on the findings of that investigation, as set forth below, the Commissioner hereby issues the following Findings of Fact and Desist and Refrain Order pursuant to Code Section 10086.

FINDINGS OF FACT

- At no time herein mentioned has UNITED FIRST INC. ("UNITED"), PAUL H. NOE II ("NOE II"), LINA NORENO ("NORENO"), JEFFREY HERNANDEZ ("HERNANDEZ"), JOSE ARMANDO PEREZ ("PEREZ"), ANNA RODRIGUEZ ("RODRIGUEZ"), ALFRED HUNDLEY ("HUNDLEY"), JONATHAN NOE ("J. NOE"), UFS EAGLES INC. ("UFS"), HUGO GONZALEZ ("H. GONZALEZ"), TAMARA GONZALEZ ("T. GONZALEZ"), AUDIT YOUR LOAN ("AYL"), or WILLIAM R. BARAHONA ("BARAHONA") been licensed by the Department in any capacity.
- JENNY SANDOVAL ("SANDOVAL") and NELLY ALVAREZ ("ALVAREZ") are presently licensed and/or have license rights under the Real Estate Law as real estate salespersons.

2 On or about February 19, 2002, the Department 3 denied the application of NOE II for a real estate salesperson license in Statement of Issues, Case No. H-29228 LA. 5 4. On or about August 13, 2004, a Desist and Refrain 6 Order, Case No. H-31172 LA, was issued to BARAHONA ordering him 7 to desist and refrain from performing any and all acts for which a real estate broker license is required unless and until he obtains such license. 10 Whenever acts referred to below are attributed to 5. 11 UNITED or to UFS, those acts are alleged to have been done by 12 UNITED or by UFS, acting alone, or by and/or through one or more 13 14 agents, associates, affiliates, and/or co-conspirators, 15 including but not limited to each of those named herein, and 16 using any fictitious name unknown at this time. 17 6. negotiation services with respect to loans which were secured by

a. Between May, 2008 and December, 2008, Martin and Elena Ortiz paid an advance fee of \$7,550 to NORENO on behalf of UNITED. The advance fees were collected pursuant to the provisions of an agreement pertaining to loan solicitation, negotiation, and modification services to be provided by UNITED with respect to a loan secured by the real property located at 44558 Stanridge Avenue, Lancaster, California 93535.

b. On or about June 30, 2008, Maria Soledad Garcia ("Garcia") paid an advance fee of \$1,000 to H. GONZALEZ on behalf of UFS. Thereafter, Garcia paid an additional advance fee in the amount of \$3,350 to H. GONZALEZ on behalf of UNITED. The advance fees were collected pursuant to the provisions of an agreement pertaining to loan solicitation, negotiation, and modification services to be provided by UNITED with respect to a loan secured by the real property located at 26663 Fleming Street, Highland, California 902346.

c. In or around June, 2008, SANDOVAL solicited
Margarito Ramirez Olague ("Olague") for the purpose of
convincing Olague to engage the services of UNITED for loan
modification and foreclosure rescue services. As a result of
SANDOVAL's solicitation Olague paid an initial advance fee of
\$1,775 to SANDOVAL on behalf of UNITED pursuant to the
provisions of an agreement pertaining to loan solicitation,
negotiation, and modification services to be provided by UNITED
with respect to a loan secured by the real property located at

13880 Ocotillo Road, Desert Hot Springs, California 92240. Thereafter, between June and December, 2008, Olague paid additional sums as advance fees to UNITED so that the total amount paid to UNITED by Olague for loan modification services was \$12,425. d. On or about September 1, 2008, Carolyn Gomez ("Gomez") paid an initial advance fee of \$3,000 to ALVAREZ on behalf of UNITED. During the period October, 2008, to December, 2008, Gomez paid additional advance fees to UNITED so that the total amount paid to UNITED as advance fees was \$7,107.21. 11 advance fees were collected pursuant to the provisions of an 12 agreement pertaining to loan solicitation, negotiation, and 13 modification services to be provided by UNITED with respect to a 14 loan secured by the real property located at 12671 Bellflower 15 Lane, Moreno Valley, California 92555. 16 On or about August 11, 2008, Puilar Aguilar paid 17 an advance fee of \$1,850 to PEREZ on behalf of UNITED. 18 advance fee was collected pursuant to the provisions of an 19 agreement pertaining to loan solicitation, negotiation, and 20 modification services to be provided by UNITED with respect to a 21 loan secured by the real property located at 20652 Rider Street, 22 Paris, California 92570. f. On or about August 22, 2008, Tracy Lee paid an 24 advance fee of \$2,570 to HUNDLEY on behalf of UNITED. 25 26 advance fee was collected pursuant to the provisions of an

agreement pertaining to loan solicitation, negotiation, and

modification services to be provided by UNITED with respect to a loan secured by the real property located at 18110 Flynn Drive, Unit 4208, Canyon Country, California 91387.

g. In or around September, 2008, Carmen Acevedo and Orquidia Penaloza paid an advance fee of \$2,250 to J. NOE on behalf of UNITED. The advance fee was collected pursuant to the provisions of an agreement pertaining to loan solicitation, negotiation, and modification services to be provided by UNITED with respect to a loan secured by the real property located at 69115 Baristo Road, Cathedral City, California 92234.

7. In or around September, 2009, AYL and BARAHONA, using the name Audit Your Loan, advertised, solicited and offered to provide forensic mortgage analysis services to borrowers with loans secured by real property in exchange for the payment of an advance fee.

CONCLUSIONS OF LAW

8. Based on the information contained in Paragraphs 6 and 7, above, UNITED, NOE II, NORENO, SANDOVAL, HERNANDEZ, ALVAREZ, PEREZ, RODRIGUEZ, HUNDLEY, J. NOE, UFS, H. GONZALEZ, T. GONZALEZ, AYL, and BARAHONA performed and/or participated in loan solicitation, negotiation and modification activities as well as advance fee handling which require a real estate broker license under the provisions of Code Sections 10131(d) and 10131.2 during a period of time when none of them licensed by the Department as a real estate broker nor employed as a real estate salesperson by the broker on whose behalf the activities

were performed, in violation of Section 10130 of the Code.

DESIST AND REFRAIN ORDER

IT'IS HEREBY ORDERED that UNITED FIRST INC., PAUL H.

NOE II, LINA NORENO, JENNY SANDOVAL, JEFFREY HERNANDEZ, NELLY

ALVAREZ, JOSE ARMANDO PEREZ, ANNA RODRIGUEZ, ALFRED HUNDLEY,

JONATHAN NOE, UFS EAGLES INC., HUGO GONZALEZ, TAMARA GONZALEZ,

AUDIT YOUR LOAN, also known as AUDIT YOUR LOAN USA, and WILLIAM

R. BARAHONA, whether doing business under their own names, or

any other names, or any fictitious name, ARE HEREBY ORDERED to

immediately desist and refrain from performing any acts within

the State of California for which a real estate broker license

is required. In particular each of them is ORDERED TO DESIST

AND REFRAIN from:

(i) charging, demanding, claiming, collecting and/or receiving advance fees, as that term is defined in Section 10026 of the Code, in any form, and under any conditions, with respect to the performance of loan modifications or any other form of mortgage loan forbearance service in connection with loans on residential property containing four or fewer dwelling units (Code Section 10085.6); and

(ii) charging, demanding, claiming, collecting and/or receiving advance fees, as that term is defined in Section 10026 of the Code, for any other real estate related services offered by them to others.

Notice: Business and Professions Code Section 10139 provides that "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using words indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)."
