COMMERCIAL LENDING CAPITAL INC. wishes to voluntarily surrender its real estate license issued by the Department of Real Estate ("Department"), pursuant to Business and Professions Code Section 10100.2.

I understand that COMMERCIAL LENDING CAPITAL INC., by so voluntarily surrendering its license, can only have it reinstated in accordance with the provisions of Section 11522 of the Government Code. I also understand that by so voluntarily surrendering its license rights, COMMERCIAL LENDING CAPITAL INC. agrees to the following:

The filing of this Declaration shall be deemed as COMMERCIAL LENDING CAPITAL INC.'s petition for voluntary surrender. It shall also be deemed to be an understanding and agreement by COMMERCIAL LENDING CAPITAL INC. that, it waives all rights it has to require the Commissioner to prove the allegations contained in the Accusation ("Accusation") filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedures Act (Government Code Sections 11400 et seq.), and that it also waives other rights afforded to it in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross examine witnesses.

I further agree on behalf of COMMERCIAL LENDING CAPITAL INC. that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Department Case No. H-37188 LA, may be considered by the Department to be true and correct for the purpose of deciding whether or not to grant reinstatement of COMMERCIAL LENDING CAPITAL INC.'s license pursuant to Government Code Section 11522.

This Declaration is not an admission by COMMERCIAL LENDING CAPITAL INC. as to the allegations in the Accusation. This Declaration is made for the purpose of reaching a resolution of allegations contained in the DRE Case number H-37188 LA, and is expressly limited to this proceeding and any other proceeding or case in which the Department of Real Estate is a party and shall not otherwise be admissible or relied upon by any third parties for any purpose.

I further agree on behalf of COMMERCIAL LENDING CAPITAL INC. to pay the Commissioner's reasonable cost (\$7,993.80) for the audit which led to this action. In calculating the amount of the Commissioner's reasonable cost, the Commissioner may use the estimated average hourly salary for all persons performing audits of real estate brokers, and shall include an allocation for travel time to and from the auditor's place of work.

COMMERCIAL LENDING CAPITAL INC. will pay such cost within 60 days of receiving an invoice from the Commissioner detailing the activities performed during the audit and the amount of time spent performing those activities.

I am aware that if COMMERCIAL LENDING CAPITAL INC. petitions for reinstatement in the future, that payment of the audit costs will be a condition of reinstatement.
