ORDER SUSPENDING REAL ESTATE LICENSE

On August 25, 2011, Respondent's real estate broker license was suspended on terms and conditions. Among those terms, conditions and restrictions, Respondent was required to submit, within six months from the aforementioned effective date, evidence of having taken and passed the Professional Responsibility Examination administered by the Department. The Commissioner has determined that Respondent has failed to satisfy this condition.

1 NOW, THEREFORE, IT IS ORDERED that Respondent's real
2 estate broker license and the exercise of any privileges
3 thereunder is hereby suspended until such time as Respondent
4 provides proof satisfactory to the Department of having taken and
5 passed the Professional Responsibility Examination, or pending
6 final determination made after hearing (see "Hearing Rights" set
7 forth below).

8 IT IS FURTHER ORDERED that all license certificates and
9 identification cards issued by the Department of Real Estate
10 which are in the possession of Respondent be immediately
11 surrendered by personal delivery or by mailing in the enclosed
12 self-addressed envelope to:



25 served on you, the Department will not be obligated or required
26 to provide you with a hearing.
