FINDINGS OF FACT

OPERANA is presently licensed and/or has license
 rights under the Real Estate Law (Part 1 of Division 4 of the
 Code) as a real estate salesperson. OPERANA's license expired on
 January 12, 2010.

At the times set forth below RBJ GROUP, DEZA and OPERANA engaged in the business of, acted in the capacity of, or advertised a real estate loan service and advance fee brokerage offering to perform solicitation, negotiation and modification of loans secured by liens on real property for compensation or in expectation of compensation and for fees collected in advance including, but not limited to, the following:

a. On or about June 8, 2008, Maria Veronica M. paid
an advance fee of \$2,500 to RBJ GROUP. The advance fee was
collected pursuant to the provisions of an agreement pertaining
to loan solicitation, negotiation, and modification services to

CONCLUSIONS OF LAW

4. The activities described in Paragraph 3, above, require a real estate license under Section 10131(d) and Section 10131.2 of the Code.

Based on the information contained in Paragraph 5. 18 4, above, RBJ GROUP, DEZA and OPERANA performed and/or 19 participated in loan solicitation, negotiation and modification 20 activities which require a real estate broker license under the 21 provisions of Code Sections 10131(d) and 10131.2 during a period 22 of time when they were not licensed by the Department as a real 23 24 estate broker nor employed as a real estate salesperson by the 25 broker on whose behalf the activities were performed in 26 violation of Section 10130 of the Code. 27 111

DESIST AND REFRAIN ORDER

Based on the Findings of Fact and Conclusions of Law stated herein:

IT IS HEREBY ORDERED that RBJ GROUP, RODRIGO M. DEZA
and JEREMY NAVALTA OPERANA, whether doing business under their
own names, or any other names, or any fictitious name, ARE HEREBY
ORDERED to immediately desist and refrain from performing any
acts within the State of California for which a real estate
broker license is required. In particular each of them is
ORDERED TO DESIST AND REFRAIN from:

11 charging, demanding, claiming, collecting and/or (i)12 receiving advance fees, as that term is defined in Section 10026 13 of the Code, in any form, and under any conditions, with respect 14 to the performance of loan modifications or any other form of 15 mortgage loan forbearance service in connection with loans on 16 residential property containing four or fewer dwelling units 17 (Code Section 10085.6); and 18

(ii) charging, demanding, claiming, collecting and/or receiving advance fees, as that term is defined in Section 10026 of the Code, for any other real estate related services offered by them to others.
