In addition, based on that investigation, the Commissioner has determined that 1 2 CASA MAR FINANCIAL CORPORATION, MARLON ORTEGA, JOEL RODRIGUEZ and ARMANDO MEMBRENO have engaged in or are engaging in acts or are attempting to engage 3 practices constituting violations of the California Business and Professions Code ("Code") 4 and/or Title 10, California Code of Regulations ("Regulations"). Based on the findings of that 5 investigation, set forth below, the Commissioner hereby issues the following Findings of Fact, 6 Conclusions of Law, and Desist and Refrain Order under the authority of Section 10086 of the 7 8 Code. FINDINGS OF FACT 9 1. From March 25, 2006 through the present, MARLON ORTEGA ("ORTEGA") 10 has been licensed by the Department as a real estate salesperson, Department License No. 11 01737070. At all times relevant herein, ORTEGA was licensed under the employment of broker 12 Metro Golden Financial Funding Group, Inc., Department License No. 01523460. 13 2. From August 25, 1990 through the present, JOEL RODRIGUEZ 14 ("RODRIGUEZ") has been licensed by the Department as a real estate salesperson, Department 15 License No. 01086979. At all times relevant herein, RODRIGUEZ was licensed under the 16 employment of broker Metro Golden Financial Funding Group, Inc., Department License No. 17 01523460. 18 3. From January 27, 2007 through January 26, 2011, ARMANDO MEMBRENO 19 ("MEMBRENO") was licensed by the Department as a real estate salesperson, Department 20 License No. 01786106. At all times relevant herein, MEMBRENO was licensed under the 21 employment of broker Metro Golden Financial Funding Group, Inc., Department License No. 22 01523460. 23 4. At no time mentioned herein has CASA MAR FINANCIAL 24 CORPORATION, also known as Casa Mar Financial Corp. ("CASA MAR"), ever been licensed 25 by the Department in any capacity. On or about April 26, 2008, ORTEGA, RODRIGUEZ and 26 MEMBRENO formed CASA MAR, a California corporation. RODRIGUEZ is CASA MAR's 27

Chief Executive Officer and an officer or director of the corporation. MEMBRENO is the Secretary, Chief Financial Officer, a director, and agent for service of process for CASA MAR. ORTEGA also served as Secretary and a director for CASA MAR.

5. All further references to "CASA MAR" include ORTEGA, RODRIGUEZ and
MEMBRENO, as well as the officers, agents and employees of CASA MAR. ORTEGA,
RODRIGUEZ and MEMBRENO engaged in the activities set forth below while doing business
as CASA MAR FINANCIAL CORPORATION, Casa Mar Financial Corp. and/or any other
fictitious names not known at this time.

6. At all times herein mentioned, CASA MAR engaged in the business of, acted
in the capacity of, advertised or assumed to act as real estate brokers in the State of California, by
doing or negotiating to do the following acts for another or others, for compensation or in
expectation of compensation by soliciting borrowers, negotiating loans, collecting payments or
offering to perform services for borrowers in connection with loans secured directly or
collaterally by liens on real property within the meaning of Code Section 10131(d).

7. For an unknown period of time beginning no later than June 27, 2008, CASA
MAR engaged in the business of soliciting to modify or negotiate loans secured by real property,
offering to negotiate the purchase, sale or exchange of real property, and claimed, demanded,
charged, received, collected or contracted for the collection of advance fees, within the meaning
of Code Section 10026, for borrowers including, but not limited to, Armando Santana R.

8. On or about June 27, 2008, MEMBRENO solicited loan modification and
negotiation services on behalf of CASA MAR to borrower Armando Santana R. Armando
Santana R. paid an initial advance fee payment of \$1,200 to CASA MAR pursuant to an advance
fee agreement for loan modification and negotiation services in connection with a loan secured
by liens on real property. CASA MAR failed to perform the loan modification and negotiation
services that had been promised to Armando Santana R. CASA MAR refused Armando Santana
R.'s demand for a refund of his advance fees.

2	9. Based on the information contained in Paragraphs 1 through 9, above, CASA		
3	MAR FINANCIAL CORPORATION, MARLON ORTEGA, JOEL RODRIGUEZ and		
4	ARMANDO MEMBRENO violated Section 10130 of the Code by engaging in the activities		
5	without first obtaining a broker license from the Department.		
6	DESIST AND REFRAIN ORDER		
7	Based upon the FINDINGS OF FACT and CONCLUSIONS OF LAW stated		
8	herein, IT IS HEREBY ORDERED THAT CASA MAR FINANCIAL CORPORATION,		
9	MARLON ORTEGA, JOEL RODRIGUEZ and ARMANDO MEMBRENO immediately desist		
10	and refrain from: performing any acts within the State of California for which a real estate broker		
11	license is required, unless you are so licensed.
