6 At all times mentioned, Respondent GLOBAL VACATIONS 7 MARKETING CORP ("GVMC") was licensed or had license rights issued by the Department of Real Estate ("Department") as a corporate 8 real estate broker by and through Respondent RICHARD DALE SARGENT 9 ("SARGENT"). GVMC was originally licensed as a corporate real 10 estate broker on May 8, 2001, by and through SARGENT as 11 designated officer. To date, the designated officer of GVMC is 12 SARGENT. GVMC registered the licensed fictitious business name 13 14 "Global Exchange Vacation Club" beginning May 8, 2001, and 15 continuing to the present.

Respondent SARGENT is licensed by the Department as a
real estate broker. Respondent SARGENT was originally licensed
as a real estate salesperson on January 25, 1986, and as a real
estate broker on June 15, 1995.

At all times herein relevant, Respondents engaged in the business of, acted in the capacity of, advertised or assumed to act as real estate brokers in the State of California within the meaning of Code Sections 10131(a). Their activities included acting for another or others in the purchase, sale, or exchange of real property interests, to wit: timeshares.

2 On or about December 3, 2008 Respondents negotiated and 3 completed the sale of 30,000 membership points in Global Exchange Vacation Club ("GEVC"), a time share subdivision, to Mr. & Mrs. 4 5 Turner for a purchase price of \$11,385.00.

At the close of escrow on December 3, 2008, Respondents 7 provided Mr. & Mrs. Turner with an expired Final Time Share Plan 8 Public Report. Respondents failed to provide the buyers with the 9 current Public Report, in violation of Code Sections 11018.1(a), 10 11234, and 11245. 11

Respondents' activities constitute a course of conduct 13 14 which includes the consumers alleged above by way of example, but 15 is by no means limited to those named consumers and their 16 experience.

In addition, Respondent SARGENT, failed to exercise 18 reasonable supervision over the activities of GVMC, and over his 19 employees, to ensure compliance with the Real Estate Laws and the 20 Commissioner's Regulations in violation of Code Sections 10159.2, 21 22 10177(h), 10177(g) and Regulation 2725.
