ORDER ACCEPTING VOLUNTARY SURRENDER OF REAL ESTATE LICENSE

On May 18, 2012, Respondents RDV CONSULTING GROUP and JOSE ROBERT DEL VALLE in connection with an investigation of possible violations of the Real Estate Law (Sections 10000 et seq., of the Business and Professions Code) and Regulations of the Commissioner (Title 10, Chapter 6, Code of Regulations) petitioned the Commissioner to voluntarily surrender their real estate broker licenses pursuant to Section 10100.2 of the Business and Professions Code.

DECLARATION

My name is JOSE ROBERT DEL VALLE. I am a licensed real estate broker. I am representing myself in this matter. I am an officer of RDV CONSULTING GROUP, a licensed real estate broker. I am authorized and empowered to sign this declaration on behalf of RDV CONSULTING GROUP and I am acting on behalf of RDV CONSULTING GROUP in this matter.

I have been informed by the Department of Real Estate that RDV CONSULTING GROUP and I are the subject of an investigation of possible violations of the Real Estate Law (Sections 10000 et seq., of the Business and Professions Code) and Regulations of the Real Estate Commissioner (Title 10,

1 Chapter 6, of the California Code of Regulations) which could  
2 result in the filing of an Accusation to revoke or suspend our  
3 real estate licenses; and pursuant to Business and Professions  
4 Code Section 10100.2, I wish to voluntarily surrender my real  
5 estate broker license as well as the real estate broker license  
6 of RDV CONSULTING GROUP issued by the Department.

7 I understand that by so voluntarily surrendering these  
8 licenses, both I and RDV CONSULTING GROUP may be relicensed as a  
9 broker, or I as a salesperson, only by petitioning for  
10 reinstatement pursuant to Section 11522 of the Government Code.

11 I agree also that the filing of this Declaration shall  
12 be deemed to be my petition to voluntarily surrender my real  
13 estate license and the license of RDV CONSULTING GROUP and shall  
14 also be deemed to be an understanding and agreement by us that  
15 upon acceptance by the Commissioner, as evidenced by an  
16 appropriate order, all affidavits and all other relevant  
17 statements, declarations and evidence obtained during the course  
18 of the investigation prior to the Commissioner's acceptance may  
19 be considered by the Department to be true and correct for the  
20 purpose of deciding whether or not to grant reinstatement of my  
21 license and the license of RDV CONSULTING GROUP pursuant to the  
22 provisions of Government Code Section 11522. This understanding  
23 and agreement is made without admitting or denying the truth or  
24 contents of the aforementioned documents.


25 I and RDV CONSULTING GROUP agree to pay the  
26 Commissioner's reasonable cost for the audit which led to this  
27 action. In calculating the amount of the Commissioner's

1 reasonable cost, the Commissioner may use the estimated average  
2 hourly salary for all persons performing audits of real estate  
3 brokers, and shall include an allocation for travel time to and  
4 from the auditor's place of work. I and/or RDV CONSULTING GROUP  
5 will pay such cost within 60 days of receiving an invoice from  
6 the Commissioner detailing the activities performed during the  
7 audit and the amount of time spent performing those activities.

8 I am aware that if I or RDV CONSULTING GROUP petition  
9 for reinstatement in the future, that payment of the audit costs  
10 will be a condition of reinstatement.

11 I declare under penalty of perjury under the laws of  
12 the State of California that the above is true and correct and  
13 that I freely and voluntarily surrender my license and all  
14 license rights attached thereto.
