The Complainant, Robin Trujillo, a Deputy Real Estate Commissioner of the State of California, for cause of Accusation against MARTIN A. GONZALEZ, a.k.a. Martin Alonzo Gonzalez ("Respondent"), alleges as follows:

1.

The Complainant, Robin Trujillo, a Deputy Real Estate Commissioner of the State of California, makes this Accusation in her official capacity.

2.

Respondent is presently licensed and/or has license rights under the Real Estate Law, Part 1 of Division 4 of the

1 California Business and Professions Code ("Code"), as a real
2 estate broker.

3 3.

4 On or about May 18, 2011, in the Superior Court of the
5 State of California, County of Los Angeles, in Case No.
6 BA357106, Respondent pled *nolo contendere* and was convicted of
7 one count for violation of Health and Safety Code Section
8 11370.6(A) (possession of money in excess of \$100,000.00 in
9 connection with sale of controlled substance), a felony.
10 Respondent was sentenced to five years probation; two days in
11 jail; and ordered to pay fines.

12 4.

13 This conviction, by its facts and circumstances, bears
14 a substantial relationship under Section 2910, Title 10, Chapter
15 6, California Code of Regulations to the qualifications,
16 functions or duties of a real estate licensee.

17 5.

18 The crime of which Respondent was convicted
19 constitutes cause under Sections 490 and 10177(b) of the Code
20 for the suspension or revocation of the license and license
21 rights of Respondent under the Real Estate Law.

22 6.

23 Code Section 10106 provides, in pertinent part, that
24 in any order issued in resolution of a disciplinary proceeding
25 before the Department of Real Estate, the Commissioner may
26 request the administrative law judge to direct a licensee found
27 to have committed a violation of this part to pay a sum not to

1 exceed the reasonable costs of the investigation and enforcement
2 of the case.
