ORDER ACCEPTING VOLUNTARY SURRENDER OF REAL ESTATE LICENSE



DECLARATION

My name is Richard Dale Sargent. I am an officer of GLOBAL VACATIONS MARKETING CORP, a licensed real estate corporate broker. I am authorized and empowered to sign this declaration on behalf of GLOBAL VACATIONS MARKETING CORP and I am acting on behalf of GLOBAL VACATIONS MARKETING CORP in this matter.


I have been informed by the Bureau of Real Estate that GLOBAL VACATIONS MARKETING CORP is the subject of an investigation of possible violations of the Real Estate Law (Sections 10000 et seq., of the Business and Professions Code) and Regulations of the Real Estate Commissioner (Title 10, Chapter 6, of the California Code of Regulations) which could result in the filing of an Accusation to revoke or suspend its real estate license; and pursuant to Business and Professions Code Section 10100.2, I wish to voluntarily surrender the real estate corporate broker license of GLOBAL VACATIONS MARKETING CORP issued by the Bureau. I understand that by so voluntarily surrendering this license, GLOBAL VACATIONS

1 MARKETING CORP may be relicensed as a corporate broker only by petitioning for
2 reinstatement pursuant to Section 11522 of the Government Code.

3 I agree also that the filing of this Declaration shall be deemed to be its petition to
4 voluntarily surrender its real estate license and shall also be deemed to be an understanding and
5 agreement by this entity that upon acceptance by the Commissioner, as evidenced by an
6 appropriate order, all affidavits and all other relevant statements, declarations and evidence
7 obtained during the course of the investigation prior to the Commissioner's acceptance may be
8 considered by the Bureau to be true and correct for the purpose of deciding whether or not to
9 grant reinstatement of its license pursuant to the provisions of Government Code Section 11522.
10 This understanding and agreement is made without admitting or denying the truth or contents of
11 the aforementioned documents.

12 I declare under penalty of perjury under the laws of the State of California that the
13 above is true and correct and that I freely and voluntarily surrender the license of GLOBAL
14 VACATIONS MARKETING CORP and all license rights attached thereto.
