

I, Anthony Morel aka Anthony Christopher Morel, ("Respondent") do hereby affirm that I have applied to the Bureau of Real Estate for a real estate salesperson license, and that to the best of my knowledge I have satisfied all of the statutory requirements for the issuance of the license, including, but not limited to, the payment of the fee therefor.

I acknowledge that by entering into this Stipulation and Waiver, I am stipulating that the Real Estate Commissioner has found grounds that justify the denial of the issuance of an unrestricted real estate salesperson license to me. I agree that there are grounds to deny the issuance of an unrestricted real estate salesperson license to me pursuant to California Business and Professions Code sections 475(a)(2), 480(a), and 10177(b) because on or about August 10, 2009, Respondent was convicted of violating California Penal Code section 485 (appropriation of lost property), a misdemeanor. In aggravation, Respondent was also convicted of violating California Vehicle Code section 23136(a) (DUI while under 21 years old), a misdemeanor.

1 I hereby request that the Real Estate Commissioner in his discretion issue a restricted real
2 estate salesperson license to me under the authority of California Business and Professions Code
3 Sections 10100.4 and 10156.5. I understand that any such restricted license will be issued
4 subject to the provisions of and limitations of California Business and Professions Code Sections
5 10156.6 and 10156.7.

6 I understand that by my signing of this Stipulation and Waiver, provided this Stipulation
7 and Waiver is accepted and signed by the Real Estate Commissioner, the Real Estate
8 Commissioner will not file a Statement of Issues based on the grounds herein, and I am waiving
9 my right to a hearing and the opportunity to present evidence at the hearing to establish my
10 rehabilitation in order to obtain an unrestricted real estate salesperson license.

11 I further understand that the following conditions, limitations, and restrictions will attach
12 to a restricted real estate salesperson license issued by the Bureau of Real Estate pursuant hereto:

13 1. The license shall not confer any property right in the privileges to be exercised
14 including the right of renewal, and the Real Estate Commissioner may by appropriate
15 order suspend the right to exercise any privileges granted under this restricted license
16 in the event of:

17 a. The conviction of respondent (including a plea of nolo contendere) to a crime
18 that bears a substantial relationship to Respondent's fitness or capacity as a real
19 estate licensee; or

20 b. The receipt of evidence that Respondent has violated provisions of the
21 California Real Estate Law, the Subdivided Lands Law, Regulations of the Real
22 Estate Commissioner, or conditions attaching to this restricted license.

23 2. I shall not be eligible to apply for the issuance of an unrestricted real estate license
24 nor the removal of any of the conditions, limitations, or restrictions attaching to the
25 restricted license until two (2) years have elapsed from the date of issuance of the
26 restricted license to Respondent.

27 3. I shall notify the Real Estate Commissioner in writing within 72 hours of any arrest

1 by sending a certified letter to the Real Estate Commissioner at the Bureau of Real
2 Estate, Flag Section, Post Office Box 137013, Sacramento, CA 95813-7013. The
3 letter shall set forth the date of Respondent's arrest, the crime for which Respondent
4 was arrested, and the name and address of the arresting law enforcement agency.
5 Respondent's failure to timely file written notice shall constitute an independent
6 violation of the terms of the restricted license and shall be grounds for the
7 suspension or revocation of that license.

8 4. With the application for license or with the application for transfer to a new
9 employing broker, I shall submit a statement signed by the prospective employing
10 broker on a form approved by the Bureau of Real Estate wherein the employing
11 broker shall certify as follows:

- 12 a. That broker has read the Stipulation and Waiver which is the basis for the
13 issuance of the restricted license; and
14 b. That broker will carefully review all transaction documents prepared by the
15 restricted licensee and otherwise exercise close supervision over the licensee's
16 performance of acts for which a license is required.


