DECLARATION

My name is JOSE BAUTISTA GARCIA. I have renewal rights to a real estate broker license.

I am representing myself in this matter.

I have been informed by the Bureau of Real Estate that I am the subject of an investigation of possible violations of the Real Estate Law (Sections 10000 et seq., of the Business and Professions Code) and Regulations of the Real Estate Commissioner (Title 10, Chapter 6, of the California Code of Regulations) which could result in the filing of an Accusation to revoke or suspend my real estate license rights; and pursuant to Business and Professions Code Section 10100.2, I wish to voluntarily surrender my real estate broker license rights issued by the Bureau.

I understand that by so voluntarily surrendering my license rights, that I may be relicensed as a broker or salesperson, or issued a new mortgage loan originator endorsement, only by petitioning for reinstatement pursuant to Section 11522 of the Government Code.

I agree also that the filing of this Declaration shall be deemed to be my petition to voluntarily surrender my real estate license rights and shall also be deemed to be an
