DECLARATION

- The filing of this Declaration shall be deemed as my petition for voluntary 1. surrender.
- It shall also be deemed to be an understanding and agreement by me that I 2. waive all rights I have to require the Commissioner to prove the allegations contained in the Accusation filed in this matter at a hearing held in accordance with the provisions of the Administrative Procedure Act (Government Code Sections 11400 et seq.), and that I also waive other rights afforded to me in connection with the hearing such as the right to discovery, the right to present evidence in defense of the allegations in the Accusation and the right to cross-examine witnesses.
- I further agree that upon acceptance by the Commissioner, as evidenced by 3. an appropriate order, all affidavits and all relevant evidence obtained by the Bureau in this matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed in the Bureau Case No. H-40626 LA, may be considered by the Bureau to be true and correct for the purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code Section 11522.
- 4. I further agree to pay the Commissioner's reasonable cost for the investigation and enforcement costs in this action. I am aware that if I petition for reinstatement in the future, that payment of the Bureau's investigation and enforcement costs in this matter, which total \$1,507.50, will be a condition of reinstatement.
- 5. A copy of the Commissioner's Criteria of Rehabilitation is attached hereto. If and when a petition application is made for reinstatement of a surrendered license or endorsement, the Real Estate Commissioner will consider as one of the criteria of rehabilitation, whether or not restitution has been made to any person who has suffered monetary losses through "substantially related" acts or omissions of Respondent, whether or not such persons are named in the investigation file in this case.
- I freely and voluntarily surrender all my licenses and license rights under the 6. Real Estate Law.
