## **DECLARATION**

My name is CHARLES RICHARD HAMEL. I am a licensed real estate salesperson and/or have license rights with respect to said license (license no. 01921699). I am representing myself in this matter.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the California Government Code), I wish to voluntarily surrender my real estate license issued by the Bureau of Real Estate ("Bureau") pursuant to California Business and Professions Code section 10100.2.

I understand that by so voluntarily surrendering my license, I may be relicensed as a broker or as a salesperson, or issued a mortgage loan originator endorsement, only by petitioning for reinstatement pursuant to California Government Code section 11522. I also understand that by so voluntarily surrendering my license, I agree to the following:

1. The filing of this Declaration shall be deemed as my petition for voluntary

- 2. It shall also be deemed to be an understanding and agreement by me that I waive all rights I have to require the Commissioner to prove the allegations that I misappropriated trust funds (i.e., rent and repair costs) and performed property management services that were not permitted by my then-employing broker, Rockpointe Realty Group, Inc. (license no. 01218499) in 2016 and/or 2017, and that I also waive other rights afforded to me in connection with the hearing, such as the right to discovery, the right to present evidence in my defense and the right to cross-examine witnesses.
- 3. In the interest of expedience and economy, I choose not to contest the allegations describe above, but to remain silent and understand that, as a result thereof, these factual allegations, without being admitted or denied, will serve as a prima facie basis for the voluntary surrender. The Real Estate Commissioner shall not be required to provide further evidence to prove said factual allegations.
- 4. I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits, and all relevant evidence obtained by the Bureau in this matter prior to the Commissioner's acceptance, and all evidence supporting the allegations described above, may be considered by the Bureau to be true and correct for the purpose of deciding whether to grant licensure, relicensure, and/or reinstatement pursuant to California Government Code section 11522 and/or a similar code section.
- 5. Prior to issuance of any new or reinstated license, I shall pay the Bureau its cost of investigation and enforcement. The cost of investigation and enforcement is two thousand four dollars and sixty cents (\$2,004.60).
- 6. A copy of the Commissioner's Criteria of Rehabilitation is attached hereto. If and when a petition application is made for licensure, relicensure, and/or reinstatement, the Commissioner will consider as one of the criteria of rehabilitation whether or not restitution has
