ORDER SUSPENDING REAL ESTATE LICENSE

TO: ALAN ROGERS STONEMAN (hereinafter "Respondent"):

On October 24, 1991, a restricted real estate broker license was issued by the Department of Real Estate to Respondent on the terms, conditions and restrictions set forth in the Real Estate Commissioner's Decision of September 30, 1991, in Case No. H-721 SA. This Order provided that the right to a restricted real estate broker license was subject to the provisions of Section 10156.6 of the California Business and Professions Code (hereinafter "Code").

On May 20, 2021, in Case No. H-41909 LA, a First Amended Accusation by a Supervising Special Investigator of the Department of Real Estate of the State of California was filed charging Respondent with a violation of section 10177(k) of the Code in that the conduct,

1 acts, and omissions of Respondent were in violation of sections 10145, 10159.2, and 10159.5  
2 and Title 10, Chapter 6, California Code of Regulations sections 2725, 2731, and 2832 and  
3 constituted cause under sections 10177(d), 10177(g), 10177(h), and 10177(k) of the Code for  
4 the suspension or revocation of all the licenses and license rights of Respondent.

5 NOW, THEREFORE, IT IS ORDERED under authority of Section 10156.7 of  
6 the Business and Professions Code of the State of California that the restricted real estate  
7 salesperson license heretofore issued to Respondent and the exercise of any privileges there  
8 under is hereby suspended pending a final determination made after the hearing on the aforesaid  
9 Accusation, or pending a subsequent agreement with the Department of Real Estate.

10 IT IS FURTHER ORDERED that all license certificates and identification cards  
11 issued by the Department of Real Estate which are in the possession of Respondent be  
12 immediately surrendered by personal delivery or by mailing via the enclosed, self-addressed  
13 envelope to:
