19 set forth, is of the opinion that you, NATIONAL FORECLOSURE
20 ADMINISTRATION, LLC and MICHAEL LOUIS CURTIS SABEDRA, have
21 violated Section 10130 of the California Business and Professions
22 Code (hereinafter the "Code") by engaging in the business of or
23 acting as a real estate broker, within the meaning of Section
24 10131(d) of the Code without first having obtained a real estate
25 broker license from the California Department of Real Estate
26 (hereinafter the "Department").

At no time herein mentioned were you, NATIONAL FORECLOSURE ADMINISTRATION, LLC or MICHAEL LOUIS CURTIS SABEDRA, licensed by the Department as a real estate broker.

At all times herein mentioned you, MICHAEL LOUIS CURTIS SABEDRA, were an agent of or in the employ of NATIONAL FORECLOSURE ADMINISTRATION, LLC, and you were compensated for performing acts pursuant to said employment in furtherance of the activities discussed in Paragraph 3 below.

During the period beginning in or about August 2008 and continuing, you, MICHAEL LOUIS CURTIS SABEDRA, and you, NATIONAL FORECLOSURE ADMINISTRATION, LLC, among other things, solicited and/or performed services for borrowers, in connection with loans secured directly or collaterally by liens on real property or on a business opportunity, for or in expectation of a compensation.

The acts you, MICHAEL LOUIS CURTIS SABEDRA, and you, NATIONAL FORECLOSURE ADMINISTRATION, LLC performed, for or in expectation of compensation, described in Paragraph 3 above are acts requiring a real estate broker license under the provisions of Section 10131(d).
