You, SULLIVAN, violated Section 10145 of the Code and Regulation 2830 by not designating all of said accounts (except for the Sullivan Business Account) as trust accounts held in your name as trustee (hereinafter referred to collectively as "trust

- You, SULLIVAN, violated Section 10145(d) of the Code
- 4 by maintaining two interest bearing accounts (Sullivan Accounts
- 5 #2 and #3) that were not in your name as trustee and for which
- 6 interest earned on the funds in these accounts inured directly to
- 7 your benefit.
- 8 VIII
- 9 At all times material herein, you, SULLIVAN, maintained
- 10 control records for the receipt and disbursement of trust funds
- 11 through the trust accounts. However, you violated Regulation
- 12 2831 in that said records failed to maintain a daily balance for
- 13 said accounts.

- At all times material herein, you, SULLIVAN, failed
- 16 to maintain a monthly reconciliation of the balance of all
