NOW THEREFORE, YOU, ANGELINE LIZARRAGO, ARE HEREBY
 ORDERED TO DESIST AND REFRAIN from performing any and all acts
 for which a real estate license is required and collecting
 advance fees until such time as you obtain the required license
 from the Department.
