Commissioner has found that I have failed to make such a showing, thereby justifying the denial of the 1 issuance to me of an unrestricted real estate salesperson license. 2

I hereby admit that the allegations of the Statement of Issues filed against me are true and correct and 3 requests that the Real Estate Commissioner in his discretion issue a restricted real estate salesperson license 4 to me under the authority of Section 10156.5 of the Business and Professions Code. I understand that any 5 6 such restricted license will be issued subject to and be limited by Section 10153.4 of the Business and Professions Code.

8 I am aware that by signing this Stipulation and Waiver, I am waiving my right to a hearing and the 9 opportunity to present evidence at the hearing to establish my rehabilitation in order to obtain an unrestricted real estate salesperson license if this Stipulation and Waiver is accepted by the Real Estate 10 Commissioner. However, I am not waiving my right to a hearing and to further proceedings to obtain a 11 restricted or unrestricted license if this Stipulation and Waiver is not accepted by the Commissioner. 12

I further understand that the following conditions, limitations, and restrictions will attach to a restricted license issued by the Department of Real Estate pursuant hereto:

- 1. The license shall not confer any property right in the privileges to be exercised including the right of renewal, and the Real Estate Commissioner may by appropriate order suspend the right to exercise any privileges granted under this restricted license in the event of:
 - The conviction of respondent (including a plea of nolo contendere) to a crime which bears a a. substantial relationship to respondent's fitness or capacity as a real estate licensee; or
 - The receipt of evidence that respondent has violated provisions of the California Real b. Estate Law, the Subdivided Lands Law, Regulations of the Real Estate Commissioner, or conditions attaching to this restricted license.
 - 2. I shall not be eligible to apply for the issuance of an unrestricted real estate license nor the removal of any of the conditions, limitations or restrictions attaching to the restricted license until two years have elapsed from the date of issuance of the restricted license to respondent.
