business of or acted as a real estate salesperson or broker, within the meaning of Section 10131(b) of the Code, without first having obtained a real estate license, in violation of Section 10130 of the Code.

Ι

At no time have you RODRIGUEZ been licensed by the Department of Real Estate ("Department") as a real estate broker or salesperson.

II

During 1997, you RODRIGUEZ, while in the employ of IRVING, engaged in the business and acted in the capacity of a real estate broker within the meaning of Section 10131(b) of the Code. Prior to doing so, you RODRIGUEZ failed to obtain a real estate broker license from the Department of Real Estate in violation of Section 10130 of the Code.

During 1997, you IRVING employed and compensated RODRIGUEZ, an unlicensed person, to perform acts for which a license is required including, but not limited to the acts described in Paragraph II above.

NOW, THEREFORE, YOU IRVING ARE ORDERED TO DESIST AND REFRAIN from employing and compensating unlicensed persons from performing acts for which a real estate salesperson or real estate broker license is required.
