## FINDINGS OF FACT

1. At all times relevant herein WATERS, individually and doing business as WEST COAST MANAGEMENT, was not and is not licensed by the Department of Real Estate to conduct activities which require a real estate license in California.

2. At least during the period of time set out below, WATERS, individually and doing business as WEST COAST MANAGEMENT, for or in expectation of compensation, negotiated to do one or more of the following acts for another or others, for or in expectation of compensation: soliciting and showing properties to prospective tenants, negotiating rental terms and preparing rental agreements on behalf of clients.

3. On or about May 11, 2009, Michael Breen employed WATERS, individually and doing business as WEST COAST MANAGEMENT, to rent, lease, operate and manage Breen's residential rental property located at 615 28<sup>th</sup> Street, Bakersfield, California 93301.

## CONCLUSIONS OF LAW

4. Based on the Findings of Fact contained in Paragraphs 1 through 3, above,
DENISE CARLENE WATERS, individually and doing business as WEST COAST
MANAGEMENT, has performed and/or participated in property management activities which
require a real estate license under Section 10131(b) of the Code during a period of time when
DENISE CARLENE WATERS, individually and doing business as WEST COAST
MANAGEMENT, was not licensed by the Department in any capacity, in violation of Section
10130 of the Code.

## DESIST AND REFRAIN ORDER

Based upon the Findings of Fact and Conclusions of Law stated herein, you DENISE CARLENE WATERS, individually and doing business as WEST COAST MANAGEMENT, are ordered to immediately desist and refrain from performing any and all acts within the State of California for which a real estate broker license is required, and in particular, that you are to ///
