**ORDER SUSPENDING RESTRICTED REAL ESTATE LICENSE**

TO: SCOT ANTHONY LEVESQUE ("Respondent"):

On or about December 20, 2012, a restricted real estate broker license was issued by the Bureau of Real Estate to Respondent on the terms, conditions, and restrictions set forth in the Real Estate Commissioner's Decision dated November 30, 2012, in Case No. H-2710 FR. That Decision granted Respondent the right to the issuance of a restricted real estate broker license subject to the provisions of Section 10156.7 of the Business and Professions Code ("Code") and to enumerated additional terms, conditions, and restrictions imposed under authority of Section 10156.6 and 10156.7 of said Code.

On December 3, 2015, in Case Number H-2968 FR, a First Amended Accusation by a Supervising Special Investigator of the State of California was filed charging Respondent

1 with violations of Sections 10232(e) 10177(d), 10232.25(d), 10166.02, 10232.4(a), 10232.5(a),  
2 10238(a), 10166.07(a) and 10163 of the Code.

3 NOW, THEREFORE, IT IS ORDERED under authority of Section 10156.7 of  
4 the Code that the restricted real estate broker license heretofore issued to Respondent  
5 SCOT ANTHONY LEVESQUE and the exercise of any privileges thereunder are hereby  
6 suspended pending final determination made after the hearing on the aforesaid First Amended  
7 Accusation.

8 IT IS FURTHER ORDERED that all license certificates and identification cards  
9 issued by the Bureau of Real Estate which are in the possession of Respondent SCOT  
10 ANTHONY LEVESQUE be immediately surrendered by personal delivery or by mailing in the  
11 enclosed, self-addressed envelope to:
