

DECLARATION

My name is RODNEY JOE BARONIAN, and I am currently licensed as a real estate broker and have license rights with respect to said license. I am represented by BRUCE A. NEILSON, Attorney at Law.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the Government Code), I wish to: 1) voluntarily surrender my real estate license issued by the Bureau of Real Estate ("Bureau"), pursuant to Business and Professions Code Section 10100.2; and 2) withdraw my request, for hearing, filed March 7, 2013, in connection with the Order to Desist and Refrain, filed January 30, 2013.

I understand that by so voluntarily surrendering my license, I may be relicensed as a broker or as a salesperson only by petitioning for reinstatement pursuant to Section 11522 of



1 the Government Code. I also understand that by so voluntarily surrendering my license, I agree  
2 to the following:


3 1. The filing of this Declaration shall be deemed as my petition for voluntary  
4 surrender.

5 2. It shall also be deemed to be an understanding and agreement by me that I  
6 waive all rights I have to require the Commissioner to prove the allegations that might have been  
7 contained in the First Amended Accusation and the Order to Desist and Refrain filed in this  
8 matter at a hearing held in accordance with the provisions of the Administrative Procedure Act  
9 (Government Code Sections 11400 et seq.), and that I also waive other rights afforded to me in  
10 connection with the hearing such as the right to discovery, the right to present evidence in  
11 defense of the allegations in the First Amended Accusation and the Order to Desist and Refrain  
12 and the right to cross-examine witnesses.

13 3. I further agree that upon acceptance by the Commissioner, as evidenced by  
14 an appropriate order, all affidavits and all relevant evidence obtained by the Bureau in this matter  
15 prior to the Commissioner's acceptance, and all allegations contained in the First Amended  
16 Accusation, filed in the Bureau Case No. H-2806 and all allegations contained in the Order to  
17 Desist and Refrain, filed in the Bureau Case No. H-2807 may be considered by the Bureau to be  
18 true and correct for the purpose of deciding whether to grant relicensure or reinstatement  
19 pursuant to Government Code Section 11522.

20 4. I freely and voluntarily surrender my license and license rights under the  
21 Real Estate Law.

22 I declare under penalty of perjury under the laws of the State of California that the  
23 above is true and correct and that this declaration was executed October 2, 2014, at  
24 10-2-14 Fresno, California.
