17	My name is JASON JOE ALVES and I am currently licensed as a real estate			
18	broker and/or have license rights with respect to said license. COUNTRYSIDE PROPERTY			
19	MANAGEMENT, INC. ("COUNTRYSIDE") is licensed as a corporate real estate broker and/or	•		
20	has license rights with respect to said license. I am an officer of COUNTRYSIDE and I am			
21	authorized to sign this declaration on behalf of COUNTRYSIDE. James J. Falcone, Esq.			
22	represents both COUNTRYSIDE and me in this matter.			
23	In lieu of proceeding in this matter in accordance with the provisions of the			
24	Administrative Procedure Act (Government Code Section 11400 et seq.), I wish to voluntarily			
25	surrender the real estate license(s) issued by the Bureau of Real Estate ("Bureau") to			
26	COUNTRYSIDE and to me, pursuant to Business and Professions Code ("Code") Section			
27	10100.2.			

It is understood that by so voluntarily surrendering these license(s), I may be
 relicensed as a broker or as a salesperson and COUNTRYSIDE may be relicensed as a broker
 corporation only by petitioning for reinstatement pursuant to Section 11522 of the Government
 Code. I also understand that by so voluntarily surrendering said license(s), both
 COUNTRYSIDE and I agree to the following:

The filing of this Declaration shall be deemed as the petition of
 COUNTRYSIDE, and also as my petition, for voluntary surrender.

2. It shall also be deemed to be an understanding and agreement by both
COUNTRYSIDE and me that we hereby waive all rights either of us may have to require the
Commissioner to prove the allegations contained in the Accusations filed in this matter at a
hearing held in accordance with the provisions of the Administrative Procedure Act (Government
Code Section 11400 et seq.), and that COUNTRYSIDE and I also waive other rights afforded to
us in connection with the hearing such as the right to discovery, the right to present evidence in
defense of the allegations in the Accusation, and the right to cross-examine witnesses.

COUNTRYSIDE and I further agree that upon acceptance by the
 Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence
 obtained by the Bureau in this matter prior to the Commissioner's acceptance, and all allegations
 contained in the Accusation heretofore filed in the Bureau Case No. H-2919 FR, may be
 considered by the Bureau to be true and correct for the purpose of deciding whether to grant
 relicensure or reinstatement pursuant to Government Code Section 11522.

4. I further understand and agree that prior to and as a condition of any petition
 for reinstatement made by COUNTRYSIDE or me pursuant to Government Code Section 11522
 being granted, I agree to pay the cost of the investigation and enforcement in Bureau Case No. H 24 2919 FR. The amount of said investigation and enforcement costs total \$2,170.35.

5. I further understand and agree that prior to and as a condition of any petition
 for reinstatement made pursuant to Government Code Section 11522 being granted, I agree to
 pay the cost of Bureau Audit No. SC130087 which found violations of Section 10145 of the

Code and/or a regulation of the Commissioner interpreting Section 10145 of the Code. The
 amount of said audit costs total \$2,065.60.

6. I further understand that if and when a petition application is made for
reinstatement of a surrendered license, the Real Estate Commissioner will consider as one of the
criteria of rehabilitation, whether or not restitution has been made to any person who has suffered
monetary losses through "substantially related" acts or omissions of Respondents, whether or not
such persons are named in the Accusation file in Bureau Case No. H-2919 FR.

I declare under penalty of perjury under the laws of the State of California that the
 above is true and correct and that COUNTRYSIDE and I freely and voluntarily surrender all our
 license(s) and license rights under the Real Estate Law.
