ORDER TO DESIST AND REFRAIN (B&P Code Section 10086)

The Real Estate Commissioner (Commissioner) of the California Bureau of Real 15 Estate (Bureau) caused an investigation to be made of the activities of MARK CHRISTOPHER 16 WILLIAMS II and ACRO DEVELOPMENT, LLC, including engaging in the business of, acting 17 in the capacity of, advertising, or assuming to act as a real estate broker in the State of California 18 within the meaning of Section 10131 (e) of the California Business and Professions Code (Code). 19 Based upon the findings of that investigation as set forth below, the Commission has determined 20 and is of the opinion that:

MARK CHRISTOPHER WILLIAMS II and ACRO DEVELOPMENT, LLC have 22 violated Section 10130 of the Code by engaging in the business of or acting as a real estate 23 salesperson or broker, within the meaning of Section 10131 (e) (Sell/Exchange a Real Property 24 Sales Contract). 25

Furthermore, based on the investigation, the Commissioner hereby issues the
 following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the
 authority of Section 10086 of the Code.

Whenever acts referred to below are attributed to ACRO DEVELOPMENT, LLC
 and/or MARK CHRISTOPHER WILLIAMS II those acts are alleged to have been done by
 MARK CHRISTOPHER WILLIAMS II, acting by himself, or by and/or through one or more
 agents, associates, affiliates, and/or co-conspirators, including, but not limited to MARK
 CHRISTOPHER WILLIAMS II.

FINDINGS OF FACT

MARK CHRISTOPHER WILLIAMS II has been licensed by the Bureau
 since January 30, 2013, as a real estate salesperson. His employing broker is Scott Tafoya.

14 2. At no time herein mentioned has ACRO DEVELOPMENT, LLC been
15 licensed by the Bureau.

¹⁶ 3. During the period of the time set out below, MARK CHRISTOPHER
 ¹⁷ WILLIAMS II and ACRO DEVELOPMENT, LLC performed one or more of the following acts
 ¹⁸ for another or others, for compensation or in expectation of compensation, within the meaning of
 ¹⁹ Section 10131 (e) of the Code: sell or offer to sell, buy or offer to buy, exchange or offer to
 ²⁰ exchange a real property sales contract.

4. Between January 3, 2014, and November 21, 2014, MARK CHRISTOPHER
 WILLIAMS II entered into 16 real property sales contracts. Subsequently, MARK
 CHRISTOPHER WILLIAMS II assigned those real property sales contracts and received an
 assignment fee for each assignment.

5. Between July 16, 2015, and December 3, 2015, MARK CHRISTOPHER
 WILLIAMS II entered into 10 real property contracts in the name of ACRO DEVELOPMENT,
 LLC. Subsequently, MARK CHRISTOPHER WILLIAMS II assigned those real property sales

1	contracts. Assignment fees were paid for each assignment to either MARK CHRISTOPHER
2	WILLIAMS II or ACRO DEVELOPMENT, LLC.
3	6. Between January 8, 2016, and June 23, 2016, MARK CHRISTOPHER
4	WILLIAMS II entered into 11 real property contracts in the name of ACRO DEVELOPMENT,
5	LLC. Subsequently, MARK CHRISTOPHER WILLIAMS II assigned those real property sales
6	contracts. Assignment fees were paid to ACRO DEVELOPMENT, LLC.
7	CONCLUSIONS OF LAW
8	Based on the Findings of Fact contained in Paragraphs 1 through 6, above, MARK
9	CHRISTOPHER WILLIAMS II and ACRO DEVELOPMENT, LLC, has assigned real property
10	contracts for compensation which require a real estate broker license under Section 10131 (e) of
11	the Code. Furthermore, MARK CHRISTOPHER WILLIAMS II accepted unlawful compensation
12	in the form of assignment fees. Thus, MARK CHRISTOPHER WILLIAMS II violated Sections
13	10130 and 10137 of the Code. ACRO DEVELOPMENT, LLC has violated Section 10130 of the
14	Code.
15	DESIST AND REFRAIN ORDER
16	Based on the Findings of Fact and Conclusions of Law stated herein, MARK
17	CHRISTOPHER WILLIAMS II and ACRO DEVELOPMENT, LLC, ARE HEREBY
18	ORDERED to immediately Desist and Refrain from performing any and all acts within the State
19	of California for which a real estate broker license is required, unless and until a real estate
20	broker license is obtained.

3	as a real estate broker or real estate salesperson without a license or who advertises using words	
4	indicating that he or she is a real estate broker without being so licensed shall be guilty of a	
5	public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by	
6 7	imprisonment in the county jail for a term not to exceed six months, or by both fine and	
8	imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars	
9	(\$60,000)"
