1	Furthermore, based on the investigation, the Commissioner hereby issues the
2	following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the
3	authority of Section 10086 of the Code.
4	<u>FINDINGS OF FACT</u>
5	1. Respondent has never been licensed by the Department in any capacity to
6	conduct real estate activity in the State of California.
7	2. On or about September 25, 1998, Respondent applied to the Department
8	for a real estate broker license using the name and personal information of his son.
9	3. On or about October 28, 1998, Respondent was issued a real estate
10	broker license in the name of his son. Since that date, Respondent has conducted real estate
11	activities as a real estate broker using the license issued in his son's name.
12	CONCLUSIONS OF LAW
13	4. Based on the Findings of Fact contained in Paragraphs 1 through 3,
14	above, Respondent obtained a real estate broker license through fraud and deceit by using his
15	son's name and personal information.
16	5. The acts and/or omissions of Respondent, as set out in Paragraph 4,
17	violate Sections 10130 (real estate licensing requirement), 10177(a) (procurement of license by
18	fraud, misrepresentation or deceit, or making material misstatement of fact in application) and
19	10177(j) (fraud or dishonest dealing) of the Code.
