17 The Complainant, Veronica Kilpatrick, a Deputy Real
18 Estate Commissioner of the State of California, for Statement of
19 Issues against DAVID CRAIG STONE (Respondent) is informed and
20 alleges in her official capacity as follows:

21 I

22 On or about November 3, 2011, the Department of Real
23 Estate of the State of California issued a real estate
24 salesperson license to Respondent on condition that Respondent
25 would not be eligible to apply for the issuance of an
26 unrestricted real estate license until two (2) years have elapsed
27

1 from the date of issuance of the restricted license to
2 Respondent.

4 On or about November 9, 2011, Respondent filed with the
5 Department of Real Estate an application for a real estate broker
6 license.

8 The matter alleged in Paragraph II is grounds to deny
9 Respondent's application for a real estate broker under Sections
10 10177(f) and 10177(j) of the California Business and Professions
11 Code.

13 The Statement of Issues is brought under the provisions
14 of Section 10100, Division 4 of the Business and Professions Code
15 of the State of California and Sections 11500 through 11528 of
16 the Government Code.
