17	The Commissioner ("Commissioner") of the California Bureau of Real Estate
18	("Bureau") caused an investigation to be made of the activities of TIMOTHY PIOWATY, KURT
19	HEINRICH KUENNECKE, NORTH COUNTY HOMES ON THE BEACH, MY LIFE AT THE
20	BEACH, OCEANSIDE SUNSHINE and SUNSHINE COASTAL PROPERTIES (collectively
21	"Respondents"). Based on that investigation the Commissioner has determined that Respondents
22	have engaged in or are engaging in acts or attempting to engage in the business of, acting in the
23	capacity of, and/or advertising or assuming to act as real estate brokers in the State of California
24	within the meaning of Business and Professions Code ("Code") Section 10131(b) (offer to lease or

rent, solicit listings of places to rent, solicit for prospective tenants, negotiate the sale, purchase or exchange of leases on real property, or collect rents from real property).

In addition, based on that investigation, the Commissioner has determined that Respondents have engaged in or are engaging in acts or are attempting to engage in practices constituting violations of the Code and/or Title 10, California Code of Regulations ("Regulations"). Based on the findings of that investigation, set forth below, the Commissioner hereby issues the following Findings of Fact, Conclusions of Law, and Desist and Refrain Order under the authority of Section 10086 of the Code.

FINDINGS OF FACT

- 1. At no time mentioned herein have TIMOTHY PIOWATY ("PIOWATY"),
 NORTH COUNTY HOMES ON THE BEACH, MY LIFE AT THE BEACH, OCEANSIDE
 SUNSHINE and SUNSHINE COASTAL PROPERTIES ever been licensed by the Bureau as real estate brokers.
- 1. KURT HEINREICH KUENNECKE ("KUENNECKE") was licensed as a real estate broker from February 13, 2007, through January 9, 2014. KUENNECKE's real estate broker license was revoked with the right to a restricted salesperson license pursuant to a Stipulation and Agreement in Bureau Case No. H-04439 SD. On January 10, 2014, KUENNECKE was issued a restricted real estate salesperson license, License No. 01136197. KUENNECKE's restricted real estate salesperson license status is in a non-working status or "NBA" meaning no broker affiliation. KUENNECKE may not engage in activities that require a real estate license.
- 3. For an unknown period of time that includes the previous three years,
 PIOWATY has represented himself to prospective tenants and real property owners, as an agent for
 Oceanside Sales and Rentals, which is a licensed fictitious business name of real estate corporation,
 Winchester Funding Group, Inc., License ID 01773744.

- 4. On or about September 1, 2010, PIOWATY solicited prospective tenant Mark C. and negotiated the lease on a condominium located at 1445 S. Pacific, Unit G, in Oceanside, California ("subject property"). PIOWATY solicited prospective tenants and collected rents for the subject property on behalf of Oceanside Sales and Rentals.
- 5. For an unknown period of time that includes the previous three years, PIOWATY has offered listings on places to lease or rent, solicited prospective tenants, and/or offered to negotiate the exchange of leases on real property while using the unlicensed fictitious business name, OCEANSIDE SUNSHINE, on a website with URL address:

 http://oceansidesunshine.v.flyer.com. PIOWATY and OCEANSIDE SUNSHINE claimed to be associated with Winchester Funding Group, Inc.
- 6. For an unknown period of time that includes the previous three years, PIOWATY and KUENNECKE have offered listings on places to lease or rent, solicited prospective tenants, and/or offered to negotiate the exchange of leases on real property while using the unlicensed fictitious business names NORTH COUNTY HOMES ON THE BEACH, on a website with URL address: http://www.mylifeatthebeach.net. KUENNECKE lists an incorrect realtor license number, 111343, as his license number on the website.

CONCLUSIONS OF LAW

Based on the information contained in Paragraphs 1 through 6, above, TIMOTHY PIOWATY, KURT HEINRICH KUENNECKE, NORTH COUNTY HOMES ON THE BEACH, MY LIFE AT THE BEACH, OCEANSIDE SUNSHINE and SUNSHINE COASTAL PROPERTIES violated Code Section 10130 by engaging in activities requiring a real estate license without first obtaining a broker license from the Bureau.

DESIST AND REFRAIN ORDER

Based upon the FINDINGS OF FACT and CONCLUSIONS OF LAW stated herein, IT IS HEREBY ORDERED THAT TIMOTHY PIOWATY, KURT HEINRICH KUENNECKE, NORTH COUNTY HOMES ON THE BEACH, MY LIFE AT THE BEACH, OCEANSIDE SUNSHINE and SUNSHINE COASTAL PROPERTIES whether doing business in their own name or any other fictitious business name, immediately desist and refrain from performing any acts within the State of California for which a real estate broker license is required, unless you are so licensed.

Notice: Business and Professions Code Section 10139 provides that "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using words indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)."
