17 The Complainant, Veronica Kilpatrick, a Supervising Special Investigator of the  
18 State of California, for Statement of Issues against CRISTIAN MALIK GOODSON, a.k.a.  
19 Cristian Goodson, ("Respondent"), is informed and alleges in her official capacity as follows:

20 1.

21 On or about June 3, 2015, Respondent made application to the Bureau of Real  
22 Estate of the State of California for a real estate salesperson license.

23 2.

24 On or about February 5, 2015, in the Superior Court of California, County of  
25 San Diego, Case No. SCD251656, Respondent was convicted for violation of California Penal  
26 Code Section 459 (second degree burglary), a misdemeanor. Respondent was placed on  
27 summary probation for 3 years and ordered to serve 9 days in jail and to pay various fines and

1 conviction bears a substantial relationship under Section 2910, Title 10, Chapter 6, California  
2 Code of Regulations to the qualifications, functions or duties of a real estate licensee.

3 3.

4 The crime of which Respondent was convicted, as alleged in Paragraph 2 above,  
5 constitutes cause for denial of Respondent's application for a real estate license under California  
6 Business and Professions Code Sections 475(a)(2)-(3), 480(a)(1)-(2), 10177(b), and 10177(j).



8 These proceedings are brought under the provisions of Section 10100, Division  
9 4 of the Business and Professions Code of the State of California and Sections 11500 through  
10 11528 of the California Government Code.

11 WHEREFORE, the Complainant prays that the above-entitled matter be set for  
12 hearing and, upon proof of the charges contained herein, that the Commissioner refuse to  
13 authorize the issuance of, and deny the issuance of, a real estate salesperson license to  
14 Respondent CRISTIAN MALIK GOODSON and for such other and further relief as may be  
15 proper under other applicable provisions of law.
