It is hereby stipulated by and between, JASON SCOTT STRODER ("Respondent"), who is represented by Frank M. Buda, Esq., and the Complainant, acting by and through Judith B.Vasan, Counsel for the Bureau of Real Estate ("Bureau"), as follows for the purpose of settling and disposing of the Statement of Issues filed on December 22, 2016, in this matter:

Respondent acknowledges that Respondent has received and read the Statement of Issues and the Statement to Respondent filed by the Bureau in connection with Respondent's application for an individual mortgage loan originator license endorsement ("MLO License Endorsement"). Respondent understands that the Real Estate Commissioner ("Commissioner") may hold a hearing on the Statement of Issues for the purpose of requiring further proof of Respondent's honesty and truthfulness and to prove other allegations therein, or that the Commissioner may in his discretion waive the hearing and grant Respondent a restricted MLO License Endorsement based upon this Stipulation and Waiver.

RE 511 K (Rev. 5/16) RE 511 K (Rev. 5/16) Respondent also understands that by filing the Statement of Issues in this matter the Commissioner is shifting the burden to Respondent to make a satisfactory showing that Respondent meets all the requirements for issuance of an MLO License Endorsement. Respondent further understands that by entering into this Stipulation and Waiver Respondent will be stipulating that the Commissioner has found that Respondent has failed to make such a showing, thereby justifying the denial of the issuance to Respondent of an MLO License Endorsement.

Respondent hereby admits that the allegations of the Statement of Issues filed against Respondent are true and correct and requests that the Commissioner in his discretion issue a restricted MLO License Endorsement to Respondent under the authority of Section 2945.4 of Title 10, California Code of Regulations and Sections 10156.5 and 10166.051 of the Business and Professions Code ("Code").

Respondent is aware that by signing this Stipulation and Waiver, Respondent is waiving Respondent's right to a hearing and the opportunity to present evidence at the hearing if this Stipulation and Waiver is accepted by the Commissioner. However, Respondent is not waiving Respondent's right to a hearing and to further proceedings to obtain a restricted or unrestricted MLO License Endorsement if this Stipulation and Waiver is not accepted by the Commissioner.

Respondent agrees that by signing this Stipulation and Waiver, the conditions, limitations and restrictions imposed on Respondent's restricted MLO License Endorsement, identified below, may be removed only by filing a Petition for Removal of Restrictions ("Petition") with the Commissioner, and that Respondent's Petition must follow the procedures set forth in Government Code Section 11522.

Respondent further understands that the restricted MLO License Endorsement issued to Respondent shall be subject to all of the provisions of Section 10156.7 of the Code and to the following limitations, conditions and restrictions imposed under authority of Section 10156.6 of the Code:

. The restricted MLO License Endorsement shall not confer any property rights in the privileges to be exercised including the right to renewal, and the Commissioner may by

appropriate order suspend the right to exercise any privileges granted under the restricted MLO License Endorsement in the event of:

- Respondent's conviction (including a plea of nolo contendere) of a crime that bears a substantial relationship to Respondent's fitness or capacity to hold a real estate license or an MLO License Endorsement; or
- b. The receipt of evidence that Respondent has violated provisions of the California Real Estate Law, the Subdivided Lands Law, Regulations of the Commissioner, or conditions attaching to the restricted MLO License Endorsement.
- 2. Respondent shall not be eligible to petition for the issuance of an unrestricted MLO License Endorsement nor the removal of any of the conditions, limitations or restrictions attaching to the restricted MLO License Endorsement until two (2) years have elapsed from the date of issuance of the restricted MLO License Endorsement to Respondent.
