3	qualifications, functions, or duties of a real estate licensee under Section 2910, Title 10,
4	Chapter 6, California Code of Regulations. On or about April 14, 2014, an Order Terminating
5	Supervised Release (Early) was filed.

7	The crime of which Respondent was convicted as alleged above constitutes
8	cause for denial of Respondent's application for a real estate license under California Business
