

	15	My name is BRENDAN ERNEST HEATH, and I am currently licensed as a real
	16	estate broker and/or have license rights with respect to said license. I am representing myself in

	20	voluntarily surrender my real estate license(s) issued by the Department of Real Estate

	22	I understand that by so voluntarily surrendering my license(s), I may be relicensed
	23	as a broker or a salesperson, or issued a new mortgage loan originator endorsement, only by
	24	petitioning for reinstatement pursuant to Section 11522 of the Government Code. I also understand
	25	that by so voluntarily surrendering my license(s), I agree to the following:

2 2. It shall also be deemed to be an understanding and agreement by me that I 3 waive all rights I have to require the Commissioner to prove the allegations contained in the 4 Accusation filed in this matter at a hearing held in accordance with the provisions of the 5 Administrative Procedure Act (Government Code Sections 11400 et seq.), and that I also waive 6 other rights afforded to me in connection with the hearing such as the right to discovery, the right to 7 present evidence in defense of the allegations in the Accusation and the right to cross-examine 8 witnesses.

9 3. I further agree that upon acceptance by the Commissioner, as evidenced by an appropriate order, all affidavits and all relevant evidence obtained by the Department in this 10 11 matter prior to the Commissioner's acceptance, and all allegations contained in the Accusation filed 12 in the Department Case No. H-05124 SD, may be considered by the Department to be true and 13 correct for the purpose of deciding whether to grant relicensure or reinstatement pursuant to Government Code Section 11522. 14

15 4. I freely and voluntarily surrender all my licenses and license rights under the 16 Real Estate Law.

17 5. I am aware that, if I petition for reinstatement in the future, the payment of 18 the Department's investigation and enforcement costs for this matter, may be a condition of 19 reinstatement.
