DECLARATION

My name is LINDA LOUISE FLEAGER, a.k.a. "Linda L. Fleager" and "Linda Fleager." I am currently licensed as a restricted real estate salesperson and/or have license rights with respect to said license(s). I am representing myself in this matter.

In lieu of proceeding in this matter in accordance with the provisions of the Administrative Procedure Act (Sections 11400 et seq., of the California Government Code), I wish to voluntarily surrender my real estate license issued by the Department of Real Estate ("Department") pursuant to California Business and Professions Code section 10100.2.

1 I understand that by so voluntarily surrendering my license, I may be relicensed
2 as a broker or as a salesperson or as an officer, or issued a mortgage loan originator
3 endorsement, only by petitioning for reinstatement pursuant to California Government Code
4 section 11522. I also understand that by so voluntarily surrendering my license, I agree to the
5 following:

6 1. The filing of this Declaration shall be deemed as my petition for voluntary
7 surrender.

8 2. It shall also be deemed to be an understanding and agreement by me that I
9 waive all rights I have to require the Commissioner to prove the allegations contained in the
10 Accusation filed in this matter at a hearing held in accordance with the provisions of the
11 Administrative Procedure Act (California Government Code sections 11400 et seq.), and that I
12 also waive other rights afforded to me in connection with the hearing, such as the right to
13 discovery, the right to present evidence in defense of the allegations in the Accusation and the
14 right to cross-examine witnesses.

15 3. I further agree that upon acceptance by the Commissioner, as evidenced by an
16 appropriate order, all affidavits and all relevant evidence obtained by the Department in this
17 matter prior to the Commissioner's acceptance, the Order Suspending Restricted Real Estate
18 License in the Department Case No. H-02975 SD, and all allegations contained in the
19 Accusation filed in the Department Case No. H-05251 SD, may be considered by the
20 Department to be true and correct for the purpose of deciding whether to grant relicensure or
21 reinstatement pursuant to California Government Code section 11522.

22 4. I freely and voluntarily surrender all my licenses and license rights under the
23 Real Estate Law.
